### What is WSCUC?

The <u>Western Senior College and University Commission (WSCUC)</u>, formerly known as

"WASC," is the accrediting agency that aids institutions in developing and sustaining effective educational programs, while assuring the community that the accredited institution has met the high standards of quality and effectiveness.

### What is TPR?

Thematic Pathway for Reaffirmation (TPR) is a streamlined, alternate pathway for reaffirmation for eligible institutions that demonstrate consistent evidence of a healthy fiscal condition, strong student achievement indicators, and sustained quality performance.

## What has been accomplished in September 2023?

- ✓ The proposed student success concept developed by the GI2025 Task Force, and the Reaffirmation Steering Committee was submitted as a resolution and reviewed by the Student Academic Policies and Procedures (SAPP) Committee.
- ✓ Scheduled Brown Bags on the proposed concept of student success took place on Sept 18-22. Two additional student sessions were held Sept. 27 &30. Nearly 110 students, faculty, staff, and administrator participants engaged in discussion, and some completed a feedback survey on the proposed concept. Slides from the brown bag sessions can be reviewed on the <u>accreditation website</u>. Quantitative and qualitative feedback was provided to the RSC for review and processing.
- ✓ The Reaffirmation Steering Committee (RSC) developed materials for in-person and virtual gallery tours to gather feedback on the self-study.
- ✓ RSC members made presentations at Student Government, Staff Council, and Academic Senate meetings.
- ✓ External Facilitators, Drs. Jennifer Mersman and Michael Nguyen, along with Faculty Leads, Megan Kenny Feister, Melissa Soenke, and Elizabeth Sowers, began phase two of CSUCI's efforts to assess our culture of assessment. Vice Provost/ALO Lavariega Monforti, our faculty leads, and external facilitators met with all program chairs across the University, as well as academic deans, as part of this work.
- ✓ The RSC hosted CSUCI's WSCUC Liaison for a brief on-campus visit.
- ✓ The CI@CI series for 2023-24 was promoted:

- RSC will plan to share and collect feedback on the draft Institutional Report via

galleries Fall 2023.

- Team Leaders will begin planning Spring 2024 accreditation events.
