I thought I should fill in a little more about the \$1855 fee for the committee. As I noted, about \$144 is for breakfasts and 3 dinners. The rest pays for all the hotels, the bus transfer from the airport to Dublin the first day and the transfer from city to airport the last day, all the tours with the exception of Aran Islands which I added as a separate line, the bus we will have for the entire tour around Ireland and Northern Ireland after Dublin (we will walk most places there), and for the bus driver/tour guide for the entire tour.

1. **Brief Activity Description.** Describe the activity and its relationship to the educational objectives of the students' program or major.

This course educates students on the historical context of Ireland's current successes and challenges, including the trajectory of the Republic of Ireland from poverty in the 1950s to wealth now. Effects of globalization on Irish politics, society, and culture will be studied and then experienced directly. Receiving special treatment in the course is the conflict in Northern Ireland, a subject that has been the focus of one of the professor's published work. After learning about the explanations for the conflict, the positions of the various actors, efforts to resolve the conflict, the 1998 peace agreement, and the ups and downs of carrying out that agreement, students will talk with members of the various parties involved and tour areas that have been the sites of significance. Also, Irish music, art, and literature have been crucial vessels for conveying the upheavals shaping past and present, and students will both learn about and then experience these media. Beyond a basic knowledge of historic events and political and social conditions, students will leave the course with an understanding of WHY Ireland is the place it is now.

2. **Relation to IRA to Course Offerings.** All IRAs must be integrally related to the formal instructional offerings of the University and must be associated with scheduled credit courses. Please list all classes that relate to the program proposed.

The travel for which the funding is requested is a key portion of UNIV 392: Ireland: From Civil War to Celtic Tiger. This course will satisfy a major elective requirement for Political Science majors.

Activity Assessment. Describe the assessment process and measures that the program will use to determine if it has attained its educational goals. **Please note a report will be due at the end of the semester.**

Upon completion of the course, students will be able to:

- 1--summarize several major events in Irish history and their impact on Ireland's politics, society, and economic situation;
- 2--describe the modern political system in the Republic of Ireland, how the society's political identities break down, and how the modernization of the society shows tensions over issues such as the role of the Church and the role of women in political life;
- 3--outline the impact globalization has had in terms of creating economic growth but bringing challenges such as illegal immigration

- 3--explain the conflict and peace process in Northern Ireland, how it is understood from the perspective of the South, from the perspective of the two major groups in the North, and from several academic/theoretical perspectives;
- 4--evaluate how themes of the student's choice are reflected in contemporary Irish literature, music, drama, and/or art;
- 5--Assess, through interviews and discussions, how various players in the Northern Ireland conflict and peace process perceive the causes and solutions to the conflict

Additional outcomes to which the travel contributes:

Students will be able to:

- evaluate various sources of information (texts read on campus compared to speakers and others in Ireland and Northern Ireland) about Ireland's conflict and its contemporary social issues
- experience first hand the historic areas in which the anti-imperial struggle and the Troubles occurred (General Post Office; Parliament buildings; Free Derry Corner, Bogside, Falls Road...)
- understand from multiple perspectives the reasons for the Northern Ireland conflict and to experience first-hand the continuing barriers to its resolution
- understand the political economy of tourism and the role of tourism in the conflict

Whether these goals are met will be measured by performance on paper assignments, exams, presentations, and with the travel portion, a travel journal. Students will be required to keep a journal in which they reflect on the specific issues described in the outcomes above. In addition, the journal provides students the opportunity to describe their experiences and the impact the journey is having on them personally and intellectually.
