15 CSUCI students travel to Paris for a one-month period to study drawing, painting, art history and French at the Paris American Academy in Paris, France. The Paris American Academy will provide the French language instruction. Art course instruction will be team taught by CSUCI Professors. Field trips to museums and historical landmarks in and around Paris will also be a significant aspect of this course.




