Description	. This event will feature Dr. Mreya Loza, curator of the Political Division of the National Museum of American History at the Smithsonian Institution, who will deliver a guest lecture on about her recently published book, Defiant Braceros: How Mgrant Workers Fought for Racial, Sexual and Political Freedom, which sheds light on the private worlds of migrant men who participated in the Bracero Program (1942-1964). Dr. Loza was part of the Bracero History Project at the Smithsonian Institution when CSU Channel Islands became a university partner in 2008 to collect additional oral histories and to bring the traveling exhibition to campus.
