Comments	To the IRA Committee: I've corresponded with the proposer, and explained my belief that CI should not be offering courses that are restricted to members of a certain race/ethnicity (there are other concerns as well, such as no syllabus coming with the proposal). At the same time, there are many good elements in this proposal, and I would encourage the committee to consider a re-framed proposal, one that turns this into a trip while taking out the UNIV391 aspect. There are previous examples of this, such as the trip that Prof. Jennie Luna proposed for a group to go out to Santa Rosa Island (I don't know the IRAProposal # for that). If the proposer has the opportunity to re-frame the proposal so that it removes some of the problematic elements while linking to instructionally related activities, it seems to me that there would be much good to support.
