*2. Brief Activity Description

Describe the activity and its relationships to the educational objectives of the students' program or major. 500 words max.

Bruising for Besos is new film (released July 2016), not yet available on DVD, by Southern California, Xicana film-maker, Adelina Anthony. It is scheduled to screen at various film festivals, including Sundance. It is the first film ever to be created by an all-Queer People of Color cast, writers, and crew. The film itself is an intimate character study of a charismatic Xicana lesbian making familia in a queer/trans people of color scene in Los Angeles. Addressing issues of love, sexuality, domestic violence and abuse, crafting a space of healing is the film's purpose and should be viewed in community. The film strives to give a complex world-view with characters many know to be true, even if rarely portrayed in mainstream films.

About the artist: ADELINA ANTHONY is a critically acclaimed and award winning two-spirit Xicana lesbian multi-genre artist, cultural activist, teaching artist, director and producer. The themes in her work address colonization, feminisms, traumas, ancestral memorias, gender, health, race & ethnicity, immigration, sexuality, land & environment & issues generally affecting our two-spirit/ queer/ lesbian/ gay/ bisexual/ transgender / womyn of color / and people of color communities. She has over 20 years of performance experience and has garnered Best Actress nominations and awards. She is the writer of over ten solo plays. A 2014 Lambda Literary Award Finalist in Drama for her first published work of solo plays, Las Hociconas; she was also a 2015 Lambda Literary Award Finalist in LGBT Drama for her ensemble play, The Beast of Times. She has an extensive list of awards and recognition such as from Latino Public Broadcasting 2014 New Media Winner and the 2016 PBS Online Film festival People's Choice Winner.

Adelina's first feature film, <u>Bruising for Besos</u>, premiered at Frameline Film Festival 2016 and also played at Outfest. The film is currently making the rounds on the national and international film festival circuits.

Adelina continues to develop works for the stage and screen, while presenting keynote speeches; readings of poetry-fiction-monologues; stand-up comedy; and creative workshops in performance and writing at select cultural centers and college campuses.

- 1.) Campus wide screening of the film
- 2.) Artist Q & A with audience (no less than 30 minutes and no more than 90 minutes)
- 3.) One class visit either before or after the screening
- 4.) One 90 minute workshop (performance or creative writing) for up to, but no more than, 12 students.
