Dear Students,

Parking permits for spring semester 2012 are now available! To simplify the purchasing process for semester permits, you are encouraged to view and download the appropriate form at: <u>http://www.csuci.edu/parking/Parking_Forms.htm</u>. Print a copy of the parking registration form, which will allow you to purchase your permit by mail.

If your application and payment are received by Friday, January 6, 2012, your permit will be mailed. Applications and payments received after this date will be processed; but will only be available for pick up at Police and Parking Services in Placer Hall. A campus or photo ID will be required at the time the permit is issued.

An appropriate CSU Channel Islands school ID number is necessary to process all applications. CASH, CHECK, MONEY ORDER, MASTERCARD, DISCOVER AND AMERICAN EXPRESS ARE THE ONLY METHODS OF PAYMENT THAT ARE ACCEPTED FOR STUDENT PERMITS. CSU Channel Islands DOES NOT ACCEPT VISA. Credit Card information may not be submitted by FAX. If you are paying by credit card, you may submit payment in person or by mail.

Please be aware, registrations will not be processed if you have an outstanding debt to the campus. We recommend that you use the convenient forms found on our website to avoid prolonged delays and waiting in lines, and to ensure your permit is received before the semester begins. Be advised that there is a "grace period" for not displaying a permit the first week of the semester to allow students time to purchase their permits. Semester permits are valid from the beginning of the semester through the last day of classes.

PLEASE NOTE: OUR OFFICE WILL HAVE EXTENDED HOURS THE FIRST WEEK OF THE SEMESTER Monday, January 23 – Friday, January 27, 2012 from 8:00 A.M. UNTIL 6:00 P.M. We encourage everyone to purchase their permits in person or by mail before the beginning of the semester to avoid long lines and delays. Our regular Customer Service hours for spring are Monday – Friday, 8:00 a.m. to 3:00 p.m. and will resume on Monday, January 30, 2012.
