## I. Meeting Minutes

Meeting minutes for September 6, September 20 and September 27 meetings were approved.

#### II. Information Items

*Resource Guide:* Staff developed a Resource Guide which will be featured on the A&S website. MAR Darakjy will present the Resource Guide at the November 1 Chairs meeting.

Using IRA funds for Capstone Projects: MAR Darakjy requested that Chairs consider the use of IRA funds to cover capstone project expenses and provide feedback at the November 1 Chairs Meeting.

Course Fees: MAR Darakjy will review course fees at upcoming department and program budget meetings and at the November 1 Chairs meeting.

### **III.** Discussion Items

Search Committees for 2 Ethnic Studies Lines and 1 Criminology TT Line: Dean Kohli requested and received the following feedback regarding a Criminology degree:

- Chair Grove noted the concern of faculty who anticipate a Criminology degree will adversely impact enrollments in the Sociology program
- Chair Buhl suggested a faculty champion to represent the Criminology degree.

- Dean Kohli proposed bringing in a consultant to explore the implications of launching a Criminology degree on campus.
- Chairs support Dean Kohli pulling the search for a TT Line in Criminology.
- Chair D. Baker agreed to write the short form with a representative from Ethnic Studies.
- Chair Alamillo suggested bringing in subject area experts and speakers to engage with faculty on the topic.

Update from APPC: This item was moved up from the Chairs' Item section of the agenda. Chair Adler informed Chairs that new programs proposals are to be submitted to APPC as a short form from by November 2 for inclusion on the Academic Master Plan. Proposals will be reviewed by the Dean and Provost to determine resources needed. Proposals will then be reviewed by the APPC prior to being sent to the Academic Senate by November 24.

Chair Adler noted that the APPC is creating a schedule template task force upon request of the Senate Executive Committee. Chairs were invited to serve on the task force, especially those who use the schedule template in ways that may not be represented by other programs. Chairs who are unable to serve on the task force were asked to email Chair Adler with feedback on the schedule template.
