Police and Parking Services (PPS) is located in Placer Hall adjacent to Lot A1 on University Drive.

Hours of Business Operation

Monday – Thursday: 8:00 a.m. – 3:00 p.m.

Fridays: 8:00 a.m. – 3:00 p.m.

Police Operations

The Police Department is open 24 hours a day, 7 days a week. The department encourages prompt reporting of all crimes, potential criminal actions, and other emergencies on campus, either in person or by calling 911 or from any telephone.

CSU Channel Islands police officers are commissioned, sworn peace officers with full enforcement authority throughout the state. Officers are responsible for reporting and investigating crimes and traffic accidents, responding to medical emergencies, enforcing laws and local ordinances, and all other incidents requiring police assistance. Criminal cases are forwarded to the Ventura County District Attorney's Office for prosecution. Police officers provide 24-hour patrol of the campus and surrounding neighborhood on foot, in vehicles, and on bicycles. Most police officers are also certified emergency medical technicians (EMT-1) and are the first responders to all medical emergencies.

The On-campus Safety Escort Service is available Monday–Thursday from 5:00-11:00 p.m. and Friday from 5:00-10:00 p.m. during fall and spring semesters.

Department members work closely with other departments on campus such as Housing and Residential Education, Student Health Services, and Personal Counseling Services in a teamwork approach to educating the campus community on such issues as alcohol and drug abuse, drinking and driving, sexual assault, and domestic violence.

Parking and Transportation Operations

Parking Enforcement

All permit and parking regulations are enforced seven days a week, 24 hours a day. Vehicles parked on campus are required to have a parking permit. There is a one week grace period at the beginning of each semester for “No Permit” violations. All other violations will be cited.

Off-Campus Bus Service

The VISTA bus service is available Monday through Friday, 7:00 a.m. to 10:20 p.m., and Saturday, 7:30 a.m. to 5:20 p.m. The cost

of a transit card is \$25 per semester for students, faculty, and staff. The bus operates from the following sites:

Oxnard

- “C” Street Transfer Point
- “C” Street & Channel Islands Blvd.
(adjacent to the backside of the Centerpoint Mall)
- Near Oxnard College
S.W. Bard Road & Simpson Drive

Camarillo

- Camarillo Metrolink Station, Lewis Road & Ventura Blvd.

To utilize this service and purchase a transit card, students should stop by PPS to complete an application and have a photo taken. Please allow 10-15 minutes to process the card.

The transit card is a countywide bus pass that can be used with other area transit providers that transfer to the CI buses. Students can also park at one of the sites and ride the bus to campus. Parking at the off-campus bus sites is free.

Parking Permits

Semester and daily permits are valid in all “A” lots and “general permit” designated parking areas, with the exception of student housing permits, which are valid only in the SH lots.

Semester Permits

All semester parking permits are available for sale through PPS and the Cashier's office. The purchase of a parking permit does not guarantee availability of space in a particular lot. Parking permits are available on a semester basis. The cost of the permit is \$145.00 (Student Housing – \$135.00). Permits purchased after the start of the semester are prorated accordingly: 1) 31-60 days, 75 percent; 2) within 61-90 days, 50 percent; and 3) 91+ days, 25 percent.

Student Housing (SH) Permit

The SH permit is only issued to student housing residents, and is only valid in the SH Lots.

Daily Permits

Daily parking permits can be purchased from permit dispensers located in Lots A1, A2, A4, or the lobby of the PPS and are valid only on the date of purchase. The cost of the daily permit is \$6.00. The dispensers will accept coins; and \$1, \$5, and \$10 bills; and give change in one dollar coins. There are no refunds for daily permits.

Semester Refunds

Permit refunds after the start of the semester are prorated accordingly: 1) within 30 days, 75 percent; 2) within 60 days, 50 percent; 3) within 90 days, 25 percent; and none thereafter. Refunds will be made within 30 days of receipt of request. There are no parking refunds for daily permits or for any amount less than \$10.00. Transit card refunds after the start of the semester are prorated accordingly: 1) within 30 days, 67 percent; 2) within 60 days, 33 percent; and none thereafter.
