
#### Requirements

Students who have all transcripts submitted by May  $3^{\rm rd}$  will have priority transfer credit review

July 15, 2021




- Final transcripts from all institutions attended must have Spring 2021 final grades posted.

- I5-business days to submit an appeal from the date on the denial letter via email
- 4-week processing/review time



- Read instructions carefully
- Unofficial transcripts are accepted
- Faxes are <u>not accepted</u>
- Handwritten statements are not accepted
- Incomplete packets are <u>not accepted!</u>


