INTENT TO ENROLL

To reserve your space for fall 2020, you must complete all three-steps of the Intent to Enroll process no later than Friday, May 1, 2020 at 11:59 p.m. Our offer of provisional admission is only valid for the fall 2020 term. You may not defer your enrollment to a later semester. Our offer of provisional admission will be withdrawn if you fail to complete all three steps of the Intent to Enroll process, as described below, by the deadline.

STEP #1: Accept our offer of Provisional Admissions

- Start by logging into your [myCI](#) and clicking on "CI Records." Your login information was sent to the email address you provided on your application.
- Once logged in, scroll down to the bottom of the page (under "Admissions") and "Accept" or "Decline" admission.

Note: A yellow triangle will appear in your Student Center after you submit your intent to enroll. You can ignore the triangle, but you must pay close attention to items on your To Do List.

To reserve your space at CSU Channel Islands, you must complete a 3-step intent to enroll process by the deadline specified in our letter offering you provisional admission. The first step is to Accept or Decline our offer of provisional admission. Accept means that you are electing to enroll at CSUCI for and are responsible for completing the next 2 steps of the intent to enroll process: Register for Orientation (step 2) and Pay for Orientation (step 3). Scroll down to the bottom of the CI Records page (under Admissions) to Accept or Decline. Our offer of provisional admission will be withdrawn if you fail to complete all 3 steps by the deadline. Our offer of provisional admission is only good for the term indicated in our offer letter. You may not defer your admission to a later semester. Please check your To Do list often (located on the right side of your CI Records page) for other enrollment requirements and updates. Students are held responsible for checking their CI email and To Do items and complying with all instructions and deadlines. NOTE: The 3 step intent to enroll process does not apply to those individuals enrolling in (a) programs offered through Extended University, (b) graduate and credential programs offered in the School of Education, and (c) applicants pursuing a second B.A. degree

INTENT TO ENROLL

STEP #2: choose a Mandatory Orientation Session

- Look for the link, "Register for Island View Orientation (IVO)." You will be directed to log back into your [myCI](#) student portal in order to register for the session that pertains to your major.

» **IMPORTANT:** *Be sure to enter your preferred email address. If you do not receive an email confirmation, then you did not successfully register. Save a copy of your confirmation email as it may be necessary to prove registration.*

STEP #3: Pay the \$175 Non-Refundable Orientation Fee

- After registering for an orientation session, you must complete the final step in the Intent to Enroll process: pay the non-refundable orientation fee. It is highly recommended that you **pay the orientation fee before logging out**. If you log out prior to submitting payment, you will need to use the payment link embedded in your [myCI](#) Student Center. To get there, log on to [myCI](#) and click on "CI Records" under "My Links."

» **IMPORTANT:** *Be sure to enter your preferred email address. You will receive an email confirmation if your payment was successfully received. If you do not receive an email, then your payment was not received. Save a copy of your confirmation email as it may be necessary to prove payment.*

Can I defer payment of the orientation fee?

That depends. Deferment means that payment of the orientation fee will be charged to your fall semester's account. If you are eligible for a deferment, you will find it noted in your [myCI](#) Student Center under "Holds" (visible in the upper-right corner of your portal).

Students who filed a 2020-2021 Free Application for Federal Student Aid (FAFSA) or the California Dream application on or before the March 2, 2020 deadline **AND** have an Expected Family Contribution (EFC) of 4,000 or less will be considered for a deferment; however, **not all students will qualify**. You must check the "Holds" section of your Student Center. **If you do not see reference to the deferral in the "Holds" section, then you must pay the fee by Friday, May 1, 2020 at 11:59 p.m. or our offer of admission will be withdrawn – no exceptions!**

Is the orientation fee refundable?

Once paid, the orientation fee is non-refundable and may not be applied to a future term. This means you will NOT receive a refund even if (a) you request to have our offer of admission (provisional or final) withdrawn at a later date or choose not to enroll; (b) our offer of provisional admission is withdrawn because you failed to meet an admission or enrollment requirement or deadline (including the transcript deadline); or (c) our offer of provisional admission is rescinded after reviewing your final transcript(s).

- » **IMPORTANT:** *You may be held responsible for paying the orientation fee if you were deferred and any of the above conditions apply.*
- » **NOTE:** You may submit an orientation-fee appeal to orientation@csuci.edu; however, you must have an extenuating circumstance for it to be approved.

CSU ADMISSION REQUIREMENTS

Our offer of provisional admission was based on information you provided on your Cal State Apply application. In order to maintain your admitted status and enroll, you must **by the end of spring 2020**:

- 1** Graduate from high school or complete a GED.
- 2** Complete the 15 year-long pattern of “a-g” college preparatory courses with a grade of C- or better. You may NOT make up any admission requirements during the summer 2020 term for fall 2020 admission.

“a-g” College Preparatory Subject Requirements	Years Required
a. U.S. History/Social Science <i>must include one year of U.S. History OR one semester of U.S. History and one semester of Government, AND one year of history/social science from either the “a” or “g” subject area</i>	2
b. English <i>4 years of college preparatory English composition/literature (including no more than one year of Advanced ESL/ELD)</i>	4
c. Mathematics <i>minimum of Algebra I, Geometry and Algebra 2 OR integrated math sequences (Students are encouraged to continue taking math through the senior year.)</i>	3
d. Laboratory Science <i>1 year physical and 1 year biological (one course from the “d” subject area and the other from the “d” or “g” area.)</i>	2
e. Language other than English <i>2 years of the same language; American Sign Language is applicable</i>	2
f. Visual and Performing Arts <i>1 year or 2-one semester courses in the same discipline required, chosen from the following disciplines: Dance, Music, Theatre, Drama, & Visual Arts (e.g., painting, web/graphics, design, film/video, inter/multimedia arts)</i>	1
g. College Prep Elective <i>chosen from the “a-f” courses beyond those used to satisfy the requirements of the “a-g” subjects, or courses that have been approved from the U.C. “a-g” list (https://hs-articulation.ucop.edu/agcourselist)</i>	1

- 3** Meet the minimum CSU Eligibility Index, which is the combination of your high school GPA (calculated from your 10th, 11th, and 12th grade a-g courses) and your test score on either the SAT (EBRW + math) or ACT composite. Important Information for Pre-Nursing Majors

Students admitted as Pre-Nursing majors have NOT been admitted into the Nursing Program. While first-time freshmen may have designated Pre-Nursing as their major upon applying to the university, admission to the university does not guarantee admission to the Nursing Program nor enrollment into all classes to meet Nursing entrance requirements. Although hundreds of students will declare Pre-Nursing as a major, **very few** (about 40 per year, which includes transfer students) will actually be admitted into the Nursing Program.

Freshman applicants will apply to the Nursing Program after they have completed their prerequisites and supplemental criteria (usually in their sophomore year). Nursing is designated as an impacted major, which means that the number of applications from qualified candidates **far exceeds** the number of available seats. As such, additional criteria are used to screen applications. Applicants are ranked-ordered for admission according to a point structure:

go.csuci.edu/NursingSupplemental and the top 70 applicants will be required to participate in a face to face group interview.

Students who declare Pre-Nursing as a major should carefully review the supplemental criteria and determine whether or not they will be competitive candidates. If not, they should plan to select a different major. For more information, please visit go.csuci.edu/NursingTrackI.

FINANCIAL AID INFORMATION

If you have not already applied for financial aid, file a [FAFSA \(https://studentaid.ed.gov/sa/fafsa\)](https://studentaid.ed.gov/sa/fafsa) or [California Dream \(CADD\) \(https://dream.csac.ca.gov/\)](https://dream.csac.ca.gov/) application by March 2, 2020. If requested, you must submit all required and completed documents by the Financial Aid Priority Document Filing Deadline of May 31, 2020. To receive a tuition fee deferral and ensure timely processing of your financial aid award, you must meet the March 2, 2020 deadline and, if applicable, the May 31, 2020 deadline. Remember, you pay for any difference between your financial aid award and your actual fees.

Tuition fee deferrals are temporary and are issued to students who meet the priority filing and document deadlines. Tuition fee deferrals will protect enrollment and delay the payment of registration fees until the financial aid process is completed. Financial Aid students with tuition fee deferral should understand that the tuition fee deferral is for enrollment fees only and does not apply to orientation and housing charges. A separate installment payment plan (HIPP) is also available for room and board fees.

RESIDENCY FOR CSU TUITION PURPOSES

Residency status determines what tuition fees you will be charged for your classes. On your admission letter, your residency status for CSU Tuition Purposes is indicated. California residency for tuition purposes eligibility criteria are established by state law and the California Code of Regulations. Your residency was determined based upon self-reported information you provided on your Cal State Apply application. Please review your residency status on your admission letter.

Those who submit their documents after the deadline, or submit incomplete documents, may not have them processed in time for the fall 2020 term.

Oct. 1, 2019

The Free Application for [Federal Student Aid \(FAFSA\)](#) and the [California Dream \(CADAA\)](#) application opens for the 2020-2021 award year.

Jan. 13, 2020

Deadline for CSUCI to receive your SAT/ACT test scores (if required).

March 2, 2020

Priority filing deadline for the Free Application for [Federal Student Aid \(FAFSA\)](#) and the [California Dream \(CADAA\)](#) application for the 2020-2021 award year.

April 4, 2020

Admitted Dolphin Day event for provisionally admitted freshmen. (Invitations will be mailed in March.)

May 1, 2020 at 11:59 p.m.

Deadline to accept our offer of provisional admission, choose a mandatory orientation session, and pay the orientation fee through [myCI](#). This deadline may not be appealed.

May 18, 2020

Priority deadline to submit your on-campus housing application and deposit or fee deferral documentation. Visit go.csuci.edu/Housing for more information.

May 31, 2020

Priority deadline to complete and submit required completed documents to the [Financial Aid & Scholarships](#) office.

June 15, 2020

Deadline to report where you plan to take [Early Start](#) classes (if required) OR submit an appeal to be exempt from enrolling in [Early Start](#) classes due to an extenuating circumstance.

July 2, 2020 at 5:00 p.m.

Deadline to register for [Early Start](#) classes (if required).

July 6, 2020 at 5:00 p.m.

Deadline to pay for [Early Start](#) classes (if required).

July 13, 2020

Priority deadline to submit Residency documents. For additional information please visit: go.csuci.edu/CAresidency.

July 13, 2020

Deadline for CSUCI to receive your final transcripts and AP scores (if any). Please have transcripts/test scores sent to:
