4. **President's Report** (Cushing)

- a. CSU Alumni Council Meeting (Krauss).
 - Meeting at San Bernadino on April 8-9. The collective bargaining agreement was reached between faculty and administration. Lou Monville, volunteer and board chair, stepped down after his part with the collective bargaining agreement. This prevented negative impact to students grades and graduation.
 - Elected new alumni trustee (Lou Monville) from CSU Bakersfield, one of his kids attends CSUCI. John Nylon
 - Treasurer report for 2016-17, surplus \$2K, balanced budget for CSU only increases to account for population increase.
 - Portfolium to be launched. Enhanced LinkedIn for students and alumni. Coursework and video, resume, Invite local businesses to improve the hiring process. Currently in testing phase. Tania to confirm the cost is free for 3 years.
 - Board alumni testing for user-friendly and value. Goal is to better connect alumni
 - Gary Ashley vice chancellor
 - 1. Class of 3 million campaign numbers
 - 2. NYC alumni reception was successful. Perhaps continue this internationally. Have had events in Chicago and D.C.
 - Stand with CSU. Still need funding and for legislation to support. Socks or glasses. #StandwithCSU social media campaign. Small CSUCI growth for next year with only adding 61 FTE.
 - Exceeded 6-year graduation rate goal 57% (+3% to our goal). Average 4.7 yrs CSU graduation rate versus 4.3 UC graduation rate
 - 5 new presidents. 10 of 23 women presidents
 - CSU website is new.
- b. Made in the CSU. Elisabeth Freeman was the first CI Distinguished alumn and she is featured in the Made in the CSU.
- c. Alumni Giving and \$16 for 2016 Update
 - 38 alumni gifts to date totaling \$1,143.
 - 434 alumni donors have given a grand total of \$34,406.70. Contributes to overall giving goal is 696 total alumni participation. 200 alumni donors needed and \$2000 needed by June 30
 - 9 friend gifts totaling \$281
