**(1) PROVIDE A DESCRIPTION OF THE ACTIVITY:**

On United Way's 25<sup>th</sup> Annual Day of Caring, Saturday, September 27<sup>th</sup>, over thirty CI students, alumni, staff, and administrators joined more than 700 volunteers from all over to work on over 30 service projects in Ventura County. The Day of Caring is an annual nationwide day of service which is an opportunity to give back to the community by helping out to complete much needed tasks. CI volunteers served at the Prototypes Women's Center in Oxnard, which is a 6 to 12 month residential treatment program for women and their children that seeks to recognize and treat addiction. Volunteers worked side-by-side with the residents to help makeover their grounds (i.e., weeding, raking, sweeping, and cutting back shrubbery). We met on campus on the day of the event for a short orientation and then rode together on the bus to Prototypes. Participants worked for 4 hours alongside the residents from 9:00-12:00 PM. We arrived back on campus around 12:30 PM for pizza and a reflection workshop.

**(2) HOW DID THE ACTIVITY RELATE TO A COURSE(S) AND/OR LEARNING OBJECTIVES?**

This activity was linked to UNIV 250: Sophomore Seminar. The learning objectives for this course included:

- Take individual and collective actions which can address issues of public concern
- Deliberate with others and present arguments clearly, logically, and creatively

This activity provided students an opportunity understand a community issue or needs, learn more about what non-profits are doing in our community and, through reflection circles, be able to speak about their community experience.

**(3) WHAT DO YOU SEE AS THE STRENGTHS OF THE ACTIVITY?**

CI has been able to participate in United Way's Day of Caring for the past 7 years, providing CI students, staff and faculty to an opportunity to directly serve our community and learn more about community issues and needs. It was a plus that we were able to experience the entire day together – from riding the bus together, serving together and coming together at the end for pizza and reflection.

**(4) WHAT WOULD YOU SAY ARE/WERE THE ACTIVITY'S WEAKNESSES?**

We had 30 students on the bus – we could always have more.

**(5) HOW WOULD YOU IMPROVE THIS ACTIVITY FOR NEXT TIME?**

The date is set by United Way and it is always on a Saturday. On the service days that the CCE plans – we may want to have them on a Friday.

**(6) WHAT DID YOU LEARN FROM THE PROCESS?**

CI students are eager to get out into the community and serve. On the bus ride back to CI many spoke about continuing to serve at Prototypes. Their spirit and enthusiasm led the CCE to establish an initiative, "Adopt an Organization." At the beginning of each academic year the



CCE, along with students, will adopt an organization and focus all our service efforts at this once site for the academic year. We will be rolling out this initiative with Student Affairs.
