(1) PROVIDE A DESCRIPTION OF THE ACTIVITY;

I hosted six evening seminars on campus for our interdisciplinary speaker series featuring 8 different speakers, from artists to activists to non-profit leaders. The topic, Citizenship on Earth, focused directly on citizen engagement with environmental issues and the need to live more sustainably on our planet.

(2) HOW DID THE ACTIVITY RELATE TO A COURSE(S) AND/OR LEARNING OBJECTIVES? Around 18 students enrolled through ESRM/COMM 496. Speakers touched on a number of topics and concerns regarding contemporary environmental management challenges and citizen engagement with them, all of which reinforce course-specific as well as general program learning outcomes:

- Understanding the resource management issues of the day\
- Articulating the interdisciplinary nature of modern environmental challenges
- Proposing novel solutions to existing resource challenges

In addition to the enrolled students, dozens of people – students, faculty, public – attended each seminar.

(3) WHAT DO YOU SEE AS THE STRENGTHS OF THE ACTIVITY?

The speaker series provides students with excellent exposure to practitioners in the environmental field and helps strengthen partnerships between CSUCI and our community. Additionally, this semester for the first time, I partnered the seminar with our campus Green Generation Club and I think it was beneficial for the club and for the participants.

For me personally, this was a great opportunity to gauge the level of interest among students in attending extracurricular events. Hosting speakers requires a lot of time/energy, so it was fantastic to see that the students responded with enthusiasm!

I do not have student evaluations of the speakers, however, since the attendance numbers were generally in excess of two-times the number of enrolled students, I see that as a solid endorsement of student interest: they came *and they kept coming* even when they were not required to! Additionally, by the end of the semester, students were voluntarily contributing snacks for all to share.
