(1) PROVIDE A DESCRIPTION OF THE ACTIVITY

633 Art in Los Angeles was intended to support student participation in required field trips for ART 110, ART 330, and ART 343 in Fall 2014, specifically by reimbursing students for parking costs at LACMA (\$12/car) and the Getty Villa and Getty Center (\$15/car). Low participation in the reimbursement scheme (as discussed below) meant that the reimbursement was extended to students in ART 101 and ART 344 in Spring 2015.

(2) HOW DID THE ACTIVITY RELATE TO A COURSE(S) AND/OR LEARNING OBJECTIVES?

The learning outcomes for all involved classes include the ability to describe, analyze, and contextualize works of human creativity in the visual arts and architecture. The opportunity to experience works of art in person is essential to developing this analytical ability. It is also essential to cultivating personal aesthetic perspectives and judgments, another Art Program and art course leaning outcome. Field trips expose general education students in ART 101 and ART 330 to a range of artworks at LACMA; students in ART 101 additionally visit a nearby commercial gallery. Other upper-division courses experience works of historical art from relevant time periods such as the European Middle Ages (the Getty Center, ART 343), classical antiquity (the Getty Villa, ART 110), or the Islamic world (LACMA, ART 344). Students in upper division courses additionally write research papers on works of art of their choosing from one of the museums visited.

(3) WHAT DO YOU SEE AS THE STRENGTHS OF THE ACTIVITY?

The activity itself is very well received. Students enjoy visiting the museums and galleries and it adds immensely to their educational experiences at CI.

(4) WHAT WOULD YOU SAY ARE/WERE THE ACTIVITY'S WEAKNESSES?

The weakness of the activity is what I sought to address with this IRA grant, namely, the expense involved for students in driving to and parking at the museum in LA. Unfortunately, because the funds could only be disbursed on a reimbursement basis, and because the reimbursement process included paperwork that had to be signed by several people and then taken by the student to petty cash (which they had to find), the vast majority of students did not request reimbursement for parking. I believe that less than \$100 of the \$920 allotted to this project was disbursed.

(5) HOW WOULD YOU IMPROVE THIS ACTIVITY FOR NEXT TIME?

In their course evaluations, students consistently note the required field trip as one of their favorite components to their art history class.

I did not track all of the reimbursement requests. Parking at LACMA is \$12; at the Getty Villa or Getty Center, \$15. I believe less than \$100 was requested in reimbursement.

Students from ART 110, ART 330, and ART 343 attended the field trips in the fall. This totaled 51 students. Students from ART 101 and ART 44 attended the spring field trips. This totaled 91 students. Overall, 142 students were served by the field trips, even if fewer than 10 of them requested reimbursements.
