## **Brief Activity Description**

The WMC request the support of an IRA grant during Fall 2019 for:

- Studio Hours program
- Weekend Writing Boot Camps
- Tutoring hours providing by professional consultants in the Writing & Multiliteracy Center (WMC).

The Studio Hours program, Weekend Writing Boot Camps, and the professional consultants ensure the academic success of students at CI by providing specialized support in writing, communication, and critical thinking skills through unique programs managed by trained, experienced tutors.

These WMC's programs (funded solely by the IRA grant) provides vital support for CI students, particularly its multilingual learners. According Dana Ferris, Professor of Linguistics and author of numbers books on writers for whom English is a second or third language, "multilingual is mainstream" in California universities and colleges. The idea of multilingual as mainstream seems to be true at CI, where 50% of CI students last year were Hispanic or Latino. Moreover, academic research over the past decade confirm the following evidence-based pedagogical understanding and approaches for second language learners:

- It takes more time for multilingual learners to learn college-level academic English than native speakers. The process requires more than one formal course on academic writing.
- Conversations on writing and consistent writing support should be integrated throughout students' learning experience at the University. In fact, this idea is recognized by the 2018 CSU GE Task Force that notes that writing and oral communication as "essential (foundational) skills" that should be "reinforced and scaffolded" throughout GE and the major.
- One-on-one conferences are considered the most effective way for multilingual learners to gain confidence through individualized sessions in developing reading/writing skills like summary, paraphrasing and synthesizing information.

The WMC is the only institutional support at CI that offers consistent pedagogical instruction on writing and communication across majors and across student's entire time at the university from freshman year to senior year, and even into Post-Baccalaureate and graduate programs.

Through drop-in and appointment tutoring, the WMC offers all CI students, but especially our multilingual students, opportunities to take more time to learn on an individualized one-to-one basis. However, the special programs supported by IRA (Studio Hours and Writing Boot Camps) provide the additional boost many of our students need: extra or more time working through writing in a friendly, supportive environment.

## WMC STUDIO HOURS

Studies in social motivation suggest that people persevere and finish difficult tasks when they see others in the room doing the same thing. This is the rationale for the group writing environment of the WMC Studio Hours and Weekend Writing Boot Camps. Because CI students may find it difficult to find space to be motivated to write without distractions, the Studio Hours provides space, motivation, and support for maintaining best practices in the writing process so that they don't fall behind.

Students are provided some light snacks and free printing to stay in our space. Food insecurity is a very important issue for students at CI. According to a study by Cal Poly, minorities in particular are significantly more likely to be food insecure vs non-minority students. At Cal Poly more than a third of their students were identified with having low food security and CI very likely has equivalent or higher numbers. Thus, the snacks we offer are an important motivator for students—it helps supports highly vulnerable students who are often the same students who need more writing support and are not college-ready in English.

More critically, students have an option to receive quick writing support from a faculty/professional consultant (an experienced consultant, who has graduated with a BA or possesses an MA), who also manages the room and can provide

quick feedback while students write. Majority of students visit Studio Hours for writing support and the peace of mind that they can get help if needed. This semester, the consultant has a MA in English and is faculty member in the English program.

There is no limit to how long students stay to write (up to two hours on weekdays; up to four hours on weekends). Our data indicate that many students take advantage of this opportunity to write slowly and steadily. The average time students spend in Studio Hours is approximately 1 hour, 30 minutes.

Studio Hours provide 14 hours of supported writing time supervised by a professional tutor beginning the second week of the semester and ending at week 15: Tuesdays, Thursdays, 8pm to 10pm; Saturdays and Sundays, 2pm to 6pm. Last semester (Spring 2019), we had the highest turn out to Studio Hours with 369 visits by 151 students who take courses in psychology, ESRM, Health Science, English, Biology, Geology, Nursing, Business, among others.

In Spring 2020, IRA pays for 211 hours of Studio Hours with a professional tutor, light snacks, promotional flyers, and posters for our sandwich boards.

#### WEEKEND WRITING BOOT CAMP

The Weekend Writing Camp is designed specifically for undergraduate students who want dedicated time for writing and support. Each Weekend Writing Boot Camp provides four hours of dedicated writing space with a professional tutor during weekends of weeks 12 and 14. In Spring 2019, we also offered four Weekend Writing Boot Camps, and it attracted 22 student participants. Like Studio Hours, the Weekend Writing Boot Camp operates "after hours," and it is vital that a professional tutor supervises and supports students who participate.

In Spring 2020, IRA pays for a total of 16 hours of Weekend Writing Boot Camps.

#### PROFESSIONAL TUTOR'S CONSULTATION HOURS

In addition, IRA pays for some hours that professional tutors provide during WMC's operational hours. This is important because the Faculty Director and Assistant Director are not always available to provide tutoring for more challenging or complex topics and tutoring situations such as students with disabilities, advanced/graduate level writing, or multilingual students needing extra help with grammar or writing.

In Spring 2020, IRA pays for a total of 106 hours of appointment tutoring by a professional tutor. For Spring, we are be able to hire a Ph.D. faculty from CI (anthropology/sociology). The higher cost for hiring CI faculty with a Ph.D. is factored into our Proposal (see Spr20 WMC Proposal--IRA budget in Excel).

We invite all students taking classes across disciplines to visit us during Studio Hours.

Last Spring 2019, students using Studio Hours the most came from English, Sociology, Business School, and Psychology.

Writing proficiency is central for critical thinking and understanding of coursework, but it is also crucial for satisfying CI's Graduation Writing Assessment Requirement (GWAR), which is currently fulfilled (for some students) through the completion of 9 units of Upper-Division Interdisciplinary General Education (UDIGE) courses. When UDIGE is fully phased out, students will need to pass GWAR-approved courses to graduate.

Student support in writing is also essential for the successful and timely graduation of CI students. The WMC Writing Studio and Weekend Writing Camps, as well as consultations offered by professional tutors support to all CI students, but they specifically offer multilingual students the much-needed time, space, and support to get writing done. IRA activity (Studio Hours, Weekend Writing Camps) supports students' metacognition of their writing process and study habits and encourages them to develop/strengthen their writing skills so that they can successfully complete their courses and graduate on time.
