This IRA is to fund student travel in support of a research presentation at a regional conference.

Students are currently enrolled in either Psy 494: Independent Research in Psychology or Psy 497: Directed Study in Psychology. The activities and learning outcomes are the same for each course (learning outcomes listed below). Students will complete a research project as the major focus of the course. This involves first reading and summarizing the relevant literature on the topic of anxiety's influence on visual attention and whether heart rate variability and emotion regulation can moderate the effects of anxiety (PLO #1). In the class, students collaborate on the development of a research design that builds upon recent research conducted at CSUCI on this topic. They also develop all needed materials for their experiment (PLO#2 and PLO#5)). The experiment is completely administered using software and incorporates objective measures, including eye tracking to determine visual attention and heart rate variability. In addition, self-report measures of anxiety and emotion regulation are also incorporated. Students will collect data using human participants (IRB approval has been requested). Students will also learn how to use relevant software to analyze physiological and eye tracking data for subsequent data analysis (PLO#4). Students will collaborate on the development of a poster for presentation of their experiment and findings at the Western Psychological Association conference in San Francisco during the Spring semester (PLO#7).

Learning Outcomes and Relation of IRA to Course Offerings

Psy 494: Independent Research in Psychology and Psy 497: Directed Study in Psychology The class activities and learning outcomes are the same for each course.

The IRA activity is integral to the research project that is the major focus of each class. Students will collaborate on a poster that describes the relevant research literature, research questions, hypotheses, methodology, results and conclusions. The requested funding is to allow students the opportunity to present the poster at a professional conference in their field hosted by the Western Psychological Association (WPA) from April 30 - May 3, 2020. Presentation at the WPA allows students the opportunity to meet with faculty at prospective graduate programs. They also gain experience in describing and defending their study's hypotheses and conclusions to an audience that includes individuals with expertise in the field. The students involved are highly motivated to enter a graduate program, and this type of experience is expected by competitive graduate programs.

Psychology majors in their junior and senior years. The experience is marketed at the orientations for incoming transfer students and through emails sent to all majors during the enrollment period.

If this is an event that is off campus, how do you plan to bring back the benefit of this event to campus?

The benefits of the conference presentation are shared when the involved students communicate their experiences with classmates, fellow Psychology club members and honor society members. This type of experience helps to create a culture of involvement among CSUCI students. The Psychology major helps students develop a broad set of skills that can be very beneficial in a number of career paths, but successful outcomes rely on students developing skills in and out of class. This project allows students to gain first-hand experience with the scientific method, technology and presentations.

Recently, students who've had similar experiences have been able to secure jobs with local employers who are conducting research and development on wearable health-related technology. This type of technology is based on the same type of measures that are used in the project. In addition, these types of workplaces require employees to work collaboratively in groups and to be comfortable presenting scientific and technological information. Providing this opportunity to students helps interested students transition into graduate programs as well as successful careers. When students learn through word of mouth about this type of experience, it is the best type of marketing possible.
