2. Brief Activity Description

Describe the activity and its relationships to the educational objectives of the students' program or major

Brief Activity Description

The exhibition, scheduled to be installed in John Spoor Broome Library Gallery beginning January 20, 2020, and opening January 27, 2020, was developed in congruence with CSUCI courses Art 100 and Art 102, and to coordinate with several other art department courses serving art majors and minors studying in the areas of painting, art history, commercial illustration, printmaking, sculpture and photography. Congruent with CSUCI Mission Statement outcome: (CSUCI graduates) will possess an education of sufficient breadth and depth to appreciate and interpret the...aesthetic worlds..."contents of the exhibition include art objects (paintings, illustrations, sculpture, prints, photographs and film sequences), as well as historical materials related to the fields of painting, photography, commercial design and printmaking. Mature and accomplished exhibiting artists will travel some distance in order to present class lecture demonstrations in accordance with the exhibition. When viewing any artwork, one also experiences the artist's concepts, vision, trajectory, and in some bodies of work-personal history...or possibly all of these at once. Experiencing the power of a good piece of art is enough in itself to activate a viewer's mind and psyche above ordinary everyday life. However, what a viewer sees when witnessing any work of art is merely the "tip of the iceberg." Many processes to create the work continue to exist out of view, just as the iceberg exists below the water's surface.

The five exhibiting artists will participate in a lecture-demonstration series related to specific course sections and open to all students, all faculty, and interested community members.

Art is always informed by and infused with a variety of other disciplines including but certainly not limited to science, history and literature. It is worth noting that the scientists and artists of the renaissance era were one and the same, and that an entire category of art exists which is referred to as "text-based," connecting visual art to literature.

In light of the CSUCI Mission Statement to "provide...education that facilitates learning within and across disciplines through integrative approaches...with multicultural and international perspectives...." the exhibition and lecture series underscores the truth that art cannot made in some sort of cultural vacuum, nor can it be completely separated from other disciplines. Art is by nature "interdisciplinary."

Learning Outcomes and Relation of IRA to Course Offerings

1. The exhibition relates to all Art Department course offerings; the following will directly participate: Art 100 Understanding Art Processes (4 sections), Art 102 Multicultural Children's Art (9 sections), (CI Mission Category(s): Multicultural Perspectives). Art 301 Two-dimensional Art: Painting Theory and Process, Art 420-Advanced Artistic Problems in

Two-dimensional art, Art 433, Women, Art and Society, (CI Mission Category(s): Interdisciplinary Approaches).

Art 435 Post-Modern Visual Culture (CI Mission Category(s): Interdisciplinary Approaches, Multicultural Perspectives), Art 332 Multicultural Art Movements (CI Mission Category(s): Interdisciplinary Approaches, Multicultural Perspectives).

2. The exhibition brings to CSUCI five prominent mature artists/academics working in diverse mediums over long periods of time. Physical, intellectual and psychological creative processes are explored in order to vivify several Art and Art History courses, particularly Art 100, "Understanding Fine Arts Processes," a course which was created to serve students from any discipline.

It may be extremely beneficial for students to experience the results of these individuals' art degrees decades later, after years of individual process and trajectory, in contrast to the college students' culture of the "new and now" trends. Art 100, (Four Sections) Guest exhibiting artist was born in Peru and raised in Europe. Artist's career trajectory and development leading to a mature art practice in the painting genre of abstraction is exhibited.

All sections of Art 100 are invited to this lecture and demonstration: Wednesday, February 19, 11:00AM-1:00PM (Art 100-1). Art 102- Multicultural Children's Art-9 sections, Art 332- Multicultural Art Movements: Artist will demonstrate the making of large hand-carved wooden cuts, (an unusual medium in itself and not a traditionally "feminine" art form), and will discuss the history of woodcarving in various cultures over time, as well as the cultural traditions which have influenced these practices: (Lecture/Demo Tuesday, February 18, 2019 1:00AM-1:00PM).

Art 433 Women, Art and Society, ART 435 - Postmodern Visual Culture, Artist will guest lecture Art 433 and Art 435 on a very unique personal journey to an artistic identity through an illustrated lecture. (Thursday, February 20, 12:00-2:00).

(Art 320 and Art 410 Painting: Emeritus founding chair of the CSUCI art department, will be brought back to campus to guest lecture, teach a painting class, and follow with individual portfolio reviews for advanced students. (Wednesday, and Thursday February 19 and 20 hours TBA).

Description of Assessment Process

My students will be required to complete a a short reflective writing assignment in conjunction with the guest lectures, and I will create a specific Qualtrics survey in response to the exhibition. The survey will address questions regarding concepts that are difficult to quantify, such as impact on students' inspiration and motivation, as well as their exposure to new ideas and concepts as a result of the event(s).

Both the writing assignment and the Qualtrics survey will examine the event's congruence with expected course goals. Should funds be granted, the data from the Qualtrics surveys (including students' feedback and comments) will be attached to the required post-event IRA Report submitted to the IRA Coordinator.
