1. Brief Activity Description:

History:

The challenges of the 21st century demand the development of critical reasoning, multilateral thinking and effective communication skills. The Communication 101 (Public Speaking) class at CSUCI, since its very inception, has been committed to taking on these challenges as part of its mission. As of this date (April 2008), approximately 180 students over the course of ten semesters, freshmen through seniors, have participated in the annual Talkin' Dolphin Speech and Debate Tournament since the fall of 2003. It is indeed one of CSUCI's longest and most comprehensive combined curricular and cocurricular activities on campus. Every semester, at least 25 students at CSUCI compete in this intra-campus tournament held in November and April.

The Talkin' Dolphins Tournament is not only a graded activity in the Communication 101 (Public Speaking) class, but it is also an opportunity for students interested in competitive speaking to hone their skills.

As an academic activity, the Talkin' Dolphin Tournament is critical to the future success of both the proposed Communication major (2007) as well as competitive speaking at CSUCI.

Strong critical thinking and communication skills are essential to meet the challenges of the 21st century. The 101 Communication Public Speaking class at CSUCI is meeting that critical need.

What is The Talkin' Dolphin Speech and Debate Tournament?

The Talkin' Dolphin Speech and Debate Tournament is a requirement of Dr. Sawyer's Communication 101 (Public Speaking) class. The tournament represents 100pts of the student's total grade in both classes. Each student in the Public Speaking class is required to present a minimum of three speeches (i.e. the student must select three events from the follow list of speeches: Impromptu, Informative, Persuasive, and Ceremonial. The Talkin' Dolphin Tournament also provides an opportunity for students to explore an intercollegiate forensics and debate competition format. The Talkin' Dolphin Tournament is both a curricular and co-curricular activity which supports the mission of the University through the development of effective speaking skills, which are essential for success in the academy as well as the workforce. These competitive opportunities allow the student to not only hone their skills as public speakers, but also provides them with the opportunity to exercise critical thinking and multilateral reasoning skills while drawing conclusions about current events and trends in the world around them through inductive and deductive reasoning. In addition, to these measurable outcomes there are also several valuable short term benefits. First of all, working with forensics almost inevitably assists students in becoming more effective writers and, in particular, speakers. This ultimately translates into higher grades. On the average, college and university forensics' team and debate GPA's usually exceed a 3.0. The Talkin' Dolphins give the whole campus the opportunity to experience the same benefits as those individuals on the Speech Team.

2. Relation to IRA Program to Course Offerings:

On Saturday, November 15, 2008 and Saturday, April 25, 2009. CSUCI will hold its biannual intra-campus Speech and Debate Tournaments. This event is instructionally related because it directly affects the students enrolled in all sections Communication

101 (public speaking) and the Communication 210 (interpersonal communication). It also directly impacts Business, Liberal Studies, Psychology, Political Science, and other programs where public speaking and oral presentations are valued as a requisite of the curriculum. This will also benefit students across campus by providing a venue in which they can practice, develop, and demonstrate both public speaking and critical thinking skills because the tournament is open to the entire campus.

3. Activity Assessment:

An overall assessment will be determined by students, faculty, and staff. Everyone participating in the event will give written feedback on an evaluation form within two weeks of the Tournament. This includes the approximate 25 students that will be competing, the 15 other students and staff who will be participating in a support role, as well as the 10-12 faculty who will be volunteering as judges.

Each round, the participants are evaluated and assessed and in the final rounds, three different judges assess the participants. Each student receives these assessments in a packet after the tournament.
