"Restoring Community Through Non-Profit Leadership & Victim Advocacy" (Class Visits and Campus-wide Event) $^{\times}$

1. Description:

The Center for Community Engagement and the Communication & Political Science Programs will co-sponsor a campus wide speaking event, ""Restoring Community Through Non-Profit Leadership & Victim Advocacy" featuring Brittany James, Victims' Rights Enforcement Officer at the Arizona Attorney General's Office of Victim Services. (see attached CV and Bio Below). This event focuses on restorative justice and victim's rights advocacy as a means to heal communities. This event will be open to the all students.

In addition to an all-campus event, Ms. James will give two classroom presentations, tailoring her presentation to compliment current course curriculum. Ms James will speak to students enrolled in *COMM340 Conlfict Management & Mediation* about victim-offender mediation and the institutionalization of victim advocacy. Ms James will also use her experience as a rape victim advocate and program coordinator with the Utah Coalition Against Sexual Assault to address students enrolled in *POLS 305 Gender and Politics* about theories of gender and the institutionalization of violence in our society.

Presenter Bio: Brittany James is the Victims' Rights Enforcement Officer at the Arizona Attorney General's Office of Victim Services. Her various roles include Ombudsman responding to victims' complaints and allegations of violations to the Arizona Victims' Bill of Rights; Investigating, facilitating and between crime victims and criminal justice agencies; managing a grant to oversee 60 criminal Justice agencies; performing audits, and working with agencies to increase their capacity in providing victims rights services. Brittany James has worked in the nonprofit and public sector for ten years. As a program coordinator with the Utah Coalition Against Sexual Assault, she worked with rape crisis centers and colleges and universities to create programming, grassroots, and community initiatives to raise awareness and prevent sexual violence. At Arizona State University, she worked to improve the capacity of area nonprofits and managed an AmeriCorps program called Public Allies. While at Public Allies, she trained AmeriCorps members and nonprofits on community engagement, volunteer management, community organizing, and Asset Based Community Development (ABCD). ABCD theory is a primary value of Public Allies, which identifies indigenous assets within a community and working to develop and leverage those assets to address needs within a community.

The all campus event is related to general course offerings in various programs such as Communication, Sociology, and Political Science. The classroom presentations and guest lectures are specific to:

Activity: On Thursday, April 29th, 2010, Brittany James, Victims' Rights Enforcement Officer at the Arizona Attorney General's Office of Victim Services spoke at two all campus events. Ms. James discussed, "The Language of Rape Culture: Breaking Down Institutional and Cultural Language of Oppression" in which she discussed the role of advocacy to change myths of rape, challenging the institutionalization of violence in our society and overcome barriers to peace. Later speaking to another set of students and faculty, she discussed "Restoring Community Through Non-Profit Leadership & Victim Advocacy" and the role of communication and public policy to advocate on behalf of those within our society who, at times, are voiceless. Both events were advertised by an all campus email (see attached).

Relation To Course: Both presentations coincided with specific courses. The Language of Rape Culture presentation coincided with *POLS 305 Gender and Politics*. Restoring Community through Advocacy coincided with *COMM340 Conflict Management & Mediation*. In both incidents the presentations related directly to previous class discussions and Ms. Bennett encouraged students to make the link between what she presented and their previous course readings and lectures.

- Related to gender relations; extremely pertinent to class curriculum

What are a few of the things you learned from this guest lecture?

- That consent can be blurred some taboos should be cleared up
- some current policy methods to help reduce the chance of rape
- that communication is really important when dealing with issues of domestic violence
- I didn't learn too much however concepts were reintroduced
- that there are new ways to educate the community about rape
- different approaches to dealing with interrelation violence how to not be a perpetrator
- rape/sexual violence assault not well defined at all. This needs to change in order to combat the problem
