- **Brief Program Description.** Describe the program and its relationship to the educational objectives of the students' program or major.
- The program will bring Sal Castro to CSU Channels to speak about his historic leadership in the school walk-outs of 1968, the largest civil rights protests by Mexican Americans in U.S. history. He will also be discussing his new book coauthored with Mario Garcia, Professor of Chicano/a Studies at UC Santa Barbara. They will also be signing this fascinating book titled Blowout: Sal Castro and the Chicano Struggle for Educational Justice. This event is tentatively scheduled for week of Sept. 12<sup>th</sup> and will be part of Latino Heritage Month. We will also have

Oxnard musical group Inlakech and slam poet, Luzma, as the opening for the event.

• Los Angeles native **Sal Castro** is an American educator and activist. In 1968 he was the leader of a series of school walkouts in East Los Angeles protesting years of inferior and discriminatory education for Mexican Americans. These "blowouts," as they were called, are the largest and most widespread civil rights protests by Mexican Americans in U.S. history, and the beginning of the urban Chicano Movement of the late 1960s and early 1970s

Mario T. García was born in El Paso Texas. He has taught at San Jose State University, San Diego State University, Yale University, and at the University of California, Santa Barbara, where he is Professor of Chicana and Chicano Studies. He is the recipient of a Guggenheim Fellowship and a Fulbright teaching Fellowship and is the author of numerous books in Chicano history.

For over 30 years **El Teatro Inlakech** has been committed to Artistic Excellence. Founded with the purpose of developing a professional bilingual theatrical company, El Teatro Inlakech has utilized the arts to document and highlight the life experiences of the Latino community. Since its establishment on September 15, 1976, the non-profit organization has provided education and entertainment to numerous participants and audience members.

Relation to CSUCI Mission: This event relates closely to the CSUCI Mission in offering students an opportunity to learn about Chicano Educational History from a multicultural and international perspective. Sal Castro will share his 40 years of experience in fighting for educational justice and Mario Garcia will situate this struggle within an international perspective by discussing the 1968 student walkout in relation to the student movement in Mexico City.

This event is also very timely given that CI has achieved the status of an Hispanic Serving Institution, (HSI) and two U.S. Department of Education grants were awarded to CI to strengthen student success and promote post-baccalaureate opportunities for Hispanic students.

• Relation to Course Offering: Faculty members from Education, History, and Chicano/a Studies will co-sponsor this event and will integrate theme of Chicano Educational Justice for their courses during Fall Semester 2011. Some of these courses include: CHS 350 (Chicano History and Culture); EDUC 445 (Chicano Child and Adolescence); ENG/HIST 430 (Tradition and Transformation: The

Sixties and Seventies in America: History, Literature, Film); EDUC 512 (Equity, Diversity and Foundations of Schooling), HIST 270 (US History to 1877); HIST 369 (California History and Culture)

**Relation to the Community:** This event will invite community members to attend, especially K-12 educators and students interested in learning more about Chicano/a educational history. We will also invite former participants of the 1968 student walkouts who now reside in Ventura County to share their experiences with CI students. MEChA students from CI will help in publicizing the event to local high schools.
