This event is the continuation of the newly annual screening of animations and films featuring the artworks created by CSUCI students. All currently enrolled CSUCI students are eligible to submit their animations and films for the inclusion of the screening. Work created in the following is accepted (though not limited to): films (short and feature length), documentary, traditional animation, flash animation, 3d computer animation, multimedia, digital video art, speed paintings, and motion graphics. Following professional standards, a panel of professional artist/academics/industry professionals will curate the screening. The screening provides CSUCI students an opportunity to showcase their work in a public venue, outside of the walls of the classroom. Additionally, the event enables the entire campus community from the student body, staff, faculty, as well as the general public and industry professionals, the opportunity to view and assess the artistic accomplishments by CSUCI students. Awards will be given to students for outstanding work in each category as selected by the jurors. The screening will commence with a red-carpet media event and public reception gala. The screening will end with an award ceremony and closing reception.

Art Program Screening of Films and Animations	May 12, 2012

**PLEASE EXPLAIN (1) DESCRIPTION OF ACTIVITY; (2) HOW DID THE ACTIVITY RELATE TO A COURSE(S); AND (3) WHAT YOU LEARNED FROM THE PROCESS.**

The Art Program F&A (Films and Animation) is a screening of films and animations dedicated for artworks created by CSUCI students. It is the hope of the activity sponsor that this event becomes an annual event held in the Spring semester for the students, the Art Program, and the general CSUCI campus community. The screening is a much-needed venue for students working in what is called time-based media. Time based media consist of artwork (such as short films, documentaries, traditional animation, etc.) that requires a screen or video display to be viewed, and, ideally, a receptive audience to view them. Unlike traditional artwork (such as paintings, drawings, sculpture, ceramics, etc.) that can be displayed in a gallery setting, time-based media is best consumed in a theatre/screening setting. This setting allows for a large group of people to view the works on a special dedicated event. This past event took place on May 12, 2012 and was a well-received and huge event! There nearly 100 pieces entered in the screening and there were over 200 people who attended the screening.

The F&A screening made it possible for students working in time-based media to showcase their works outside of the classroom setting. The students in the Art Program produce high quality works and this screening has made possible an additional way to show case the talents of our students. Students from the courses listed on the IRA fund request form directly benefited, as they were able to display their creative works in front of general audience. Students, faculty, staff, and the general public were on hand to view the works. Additionally, holding up to industry standards, a small committee of industry professionals juried the screening. The committee's combined efforts lead to the selection of the top three in the following areas: Best Character Design, Best Character Animation, Best Live Action, Best Motion Graphics, Best Digital 2D, Best Traditional 2D. In addition, there were two special awards: Audience Choice (the audience selected their favorite piece from all screened submissions) and Best in Show (the jurors' top selected work).

Being that this was the first time this activity was held, there was much that was learned. A system was developed for student submission, as well as a system to review and comment using youtube.com and vimeo.com. Additionally, it became apparently clear that working with vendors that have an establish relationship with the university is

the best option as there is no need to fill out new paper work and wait for that paper work to be process. This allows more time and energy to be utilized in the planning of the screening. Most import, the activity demonstrated how eager the students were to show case their work and how willing the public were to celebrate the accomplishments of the students.
