1. **Brief Activity Description.** Describe the activity and its relationship to the educational objectives of the students' program or major.

This is a Guest Performance/Lecture for the HIST/PAMU 337 "Music in History" course. The other sections of this course will also be encouraged to attend this presentation. Our students love seeing these live concerts, and the concerts greatly enrich their understanding of the music being studied in this music history course. It is very important for University students who are studying the performing arts to experience live music performances by high caliber professional musicians. For that reason, I have invited pianist Gary Nesteruk to perform for our class during the Fall 2013 semester. Mr. Nesteruk is a veteran of Hollywood recording studios, and he has also toured around the world with top musical artists. Gary Nesteruk possesses expertise in the areas of classical music, jazz, and popular music. During this presentation, Mr. Nesteruk will discuss important aspects of the musical compositions that he performs. We will encourage the students to ask questions of this guest performer, to contribute to their understanding of the music and the performance process. As a part of this experience, and to further the University's goals of writing across the curriculum, my class will be required to write a multiple page concert review about this performance. Mr. Nesteruk will perform music from the Baroque, Classical, Romantic, and Impressionist periods in music. He will also perform some jazz music literature, such as the compositions of Duke Ellington. The instructor of the course (myself) will join with Mr. Nesteruk on some of the musical offerings, and together we will play some of the Bach flute sonatas, some of Mozart's clarinet music, and other musical selections.

This Lecture/Performance series is associated with the HIST/PAMU 337 "Music in History" course, and these events will be announced via flyers, the Performing Arts events calendar, the CSUCI home page (under the "Events" tab), and through social media. The concert will be announced in all the Performing Arts classes. Some of the courses that would directly benefit from these concerts would include:

- 3. **Learning Outcomes.** List all expected learning outcomes, as connected specifically with each course listed in #2.
- PA 101 "Introduction to the Performing Arts": An opportunity to observe a fine musical performance by a very accomplished musician. Students will become acquainted with excellent musical repertoire from both the classical and jazz music styles. Students will witness the performance process and will be able to ask the artist about his preparation methods, and inquire about his mindset while in performance mode. Valuable lessons can be learned here.
- **PAMU 100 "Music Appreciation":** Students will gain an additional appreciation of various musical styles by witnessing this fine musical performance. Students will become acquainted with excellent musical repertoire from both the classical and jazz music styles. Witnessing live musical performances are essential to the study of music.
- PA 202 "Integrating Dance, Music and Theatre": Students will gain familiarity and knowledge about some of the musical works of history's greatest composers. The students will undoubtedly encounter these same composers and musical styles in their future journeys through the worlds of dance, music, and theatre. Connections between dance and music will be pointed out when for instance; a suite of Baroque era music incorporates European dance rhythms such as the minuet, gigue, or sarabande.
- **PAMU 333 "Varieties of Musical Experience":** Students will gain familiarity and knowledge about some of the musical works of history's greatest composers. Students will observe how a versatile, well studied musician (Mr. Nesteruk) can straddle both the classical and jazz music worlds. Students will increase their appreciation for the tremendous variety of music that has been created by humans throughout history.
- **PAMU 161 "Music Fundamentals":** many of the basic musical concepts taught in this class will be demonstrated through the music presented on this program. By observing this live music performance, students will increase their understanding of the musical elements of melody, rhythm, and harmony. The students' awareness of musical composition forms and structures will also be enhanced.

PAMU 261 "Music Theory": many of the musical concepts taught in this class will be demonstrated through the music presented on this program. By observing this live music performance, students will increase their understanding of the musical elements of melody, rhythm, harmony, chord progressions, and thematic/motivic development.

PAMU "Jazz In America": Besides hearing several jazz style compositions performed at this recital, these students will also learn more about the European harmonic systems that were part of the foundation of jazz music. Students will observe that musical theme and variation models existed for hundreds of years in European art music, as did a rich heritage of musical harmony. Students will be reminded that when these European musical elements were combined with the African-American musical heritage found in New Orleans, jazz was born. Mr. Nesteruk is a wonderful interpreter of the music of one of the greatest composers in jazz history, Mr. Duke Ellington.

PAMU 337 "Music In History": Since music from several different centuries will be presented during this recital, these students will gain more familiarity with the musical characteristics of each musical era, and also become more familiar with some well known musical works by some of history's greatest composers. Students will also learn about the forms and structures of the music being performed. During the performance, the historical background of these pieces of music will be discussed.

PAMU 109 & 309 - Private Lessons (all instruments): By observing the performance of a highly skilled musician such as Mr. Nesteruk, students who are studying ANY musical instrument can gain valuable insights about the preparation and performance process, and then can apply that kind of dedicated work ethic towards their own musical endeavors.

PAMU 307 "University Chorus": Students will listen to music by some very famous composers at this recital. It is very likely that the vocalists in the University Chorus will at some time perform other works by these same composers. Through the performances and discussion during this presentation, our CI chorus members will gain greater insights into the musical worlds of composers like Bach and Mozart. With this greater understanding of the music of those eras, our vocalists can bring a more authentic interpretation to their own performances of similar music.

PAMU 308 "University Orchestra": Our University musicians will have the opportunity to observe a high caliber performance by our guest artist. Through dialog exchanges with the artist, our students will gain a better understanding of the huge amount of practice time that must be invested by someone who wants to become highly skilled in music. Lessons gleaned from observing our highly skilled performer, can be applied to our CI students' own music practice/performance.

All students attending the event will be asked to write an assessment to the concert, using the IRA Student Evaluation form. They will write their thoughts about the importance of the event, and how they have benefitted from it. The students in my courses will be required to write a multiple page, in-depth review/summary of what they learned about the musical styles that were demonstrated at the events. The writing assignment for my class will serve to address our University's goal of writing across the curriculum.

Gary Nesteruk is a top tier professional musician in Los Angeles. He will be driving up from the Los Angeles metropolitan area for this performance. I am requesting an **honorarium of \$250 to be paid to Gary Nesteruk**. Gary's services would ordinarily cost twice that much, so this is a very reasonable price that he has agreed to. We also need to budget \$25 for ink costs to have promotional posters printed.

Total IRA funds requested = \$275.

This event will also be posted on the Performing Arts Events calendar, and in the Events section of the myCI website.
