1. **Brief Activity Description.** Describe the activity and its relationship to the educational objectives of the students' program or major.

This is live performance event to benefit the students in PADA 458 Dance Ensemble, PADA 353 Jazz Dance II, PADA 255 Modern Dance II, PAMU 308 University Orchestra, PAMU 109 Music Private Lessons, PAMU 202 Group Guitar Lessons, PATH 380 Acting II, PATH Directing 382, ART 322 & 422 Time Based Media Art (all PA and ART courses offered Spring 2014 are invited and encouraged to participate) courses as a collaborative and cumulative performance opportunity to demonstrate skills accumulated in performing arts classes. This event is open to all

CSUCI students as audience members and as outreach to the surrounding community. It will take place on the lawn between Malibu Hall and the Library as a site-specific evening of performing arts and art. The audience will be encouraged to bring picnic dinner and blankets as an informal viewing arrangement.

As per the course description(s) and learning objectives:

PADA 458: A dance repertory and performance class with emphasis in developing skills for performing ballet, modern, jazz, historic and/or other forms of theatrical dance

PAMU 308: Rehearsal and **performance** of the masterworks of orchestral literature from the Baroque through the Modern period. Repeatable for up to 8 units.

PATH 380: Emphasizes character work and contemporary acting theories. Includes **performance** of scenes from contemporary multicultural plays.

ART 322 -Studio topics explore thematic projects involving visual continuity and technical competency working in digital time-based art, animated graphics and visual effects. **Projects focus on the integration of artistic concept and technological proficiency in the creation of time-based digital art presented on video**, CD ROM and DVD.

b. For each class listed in #2a, describe in detail how exactly the IRA activity will be integrated with the class's activities, how often/ on what expected date(s), and to what extent.

This event will give the students an opportunity to perform the skills acquired throughout the semester. Faculty and student choreographed, directed, and/or composed works will be presented in a site-specific picnic style atmosphere. The emphasis of the performance will be on the diversity of styles and cultures represented in the student population.

The process of creating this performance and the subsequent performance will encourage the students to ask how the technique(s) of their art form works collaboratively with another to create a real world artistic experience.

The process will encourage students to develop skills as performers in a concert setting. Artistic choices of lighting, costume, and style that have an impact on the overall effect of performance will be explored and analyzed.

3. Learning Outcomes. List all expected learning outcomes, as connected specifically with each course listed in #2.

As part of the student's assignments in the PADA 458 Dance Ensemble, PADA 353 Jazz Dance II, PADA 255 Modern Dance II, PAMU 308 University Orchestra, PAMU 109 Music Private Lessons, PAMU 202 Group Guitar Lessons, PATH 380 Acting II, PATH Directing 382, ART 322 & 422 Time Based Media Art courses, they are required to participate in the capacity of performer or creator as a demonstration of skills acquired and learned throughout the semester. This provides them with the unique opportunity to develop an evening length concert of original works through collaboration. The outdoor nature of the concert requires them to consider the application of performance beyond a proscenium stage setting, both the limitations and freedoms of the given setting. The collaborative process between dancer, musician, actor, artsit will be explored. Collaboration between the performing arts and arts will create in developing inter-personal and intra-personal communication skills.

As part of final project a questionnaire will be given to the students to assess individual growth. A post-mortem between the instructors of participating classes will be held to assess activities benefits and challenges so the activity can evolve each year.






