In addition to her lecture, Profess Ruiz will be asked to conduct a workshop on research and writing for students in the Humanities and Social Sciences of CI that include, but are not limited to, the programs of Art, Chicana/o Studies, Education, English, History, Sociology and others, Hispanic Heritage Month Fall 2015: Professor Echaveste (who grew up in the City of Oxnard) also served as served as the assistant to the president and deputy chief of staff to President William Clinton from From 1998 to 2001. Professor Echaveste has be recently nominated by President Barack Obama to be the next Ambassador to Mexico.
