Conditions and Considerations	Field Trip			
Brief Activity Description	Students from two anthropology courses will participate in this service learning fieldtrip: students from ANTH 352 (Applied Anthropology), and a proposed UNIV 498 course (pending). As a part of these courses, students undertake archaeological fieldwork to reconstruct human activities associated with coastal and marine resources, both in the past and present. Activities in particular focus on how the Chumash lived on the island in prehistory, as well as what cultural and ecological changes occurred with Euroamerican occupation of the island in the 19th and 20th centuries. Travel to Santa Rosa Island will help students experience and better understand the challenges associated with travel within the coastal and marine			
	environment, as well as the benefits and challenges associated with obtaining and managing coastal resources. Furthermore, the fieldwork has a service learning component, as we are partnering with the National Park Service to begin long term monitoring of historic and archaeological resources on the island. This fieldtrip in particular is designed to pilot the monitoring program which the NPS and Cl partners will commence at the ranch headquarters of the Vail Ranch. Students will be divided into 4 different work groups and will work on different aspects of the monitoring program (historic structure recording, archaeological survey, photographing historic artifacts in the barn, etc).			
	Anthropology faculty members Delaney and Perry have partnered with two colleagues from CSU Los Angeles and CSU Fullerton as a part of this monitoring program. All four archaeologists will attend this trip to serve as advisors for the 4 groups of students.			
	The trip funding request is for 15 students, and 4 faculty members.			
Learning Outcomes and Relation to IRA to	UNIV 498: As a part of UNIV 498 students will be required to complete sites reports and research papers associated with their archaeological work on the mainland and Santa Rosa Island. Students will be expected to apply information learned and experienced on the field trip to these assignments.			
Course Offerings	ANTH 352: Applied Anthropology focuses on the ways anthropological skills, methods, and theory can be applied in situations outside academia. While on the island, students from this class will go beyond class discussion and learn how archaeologists work to record and monitor
