| Brief Activity Description | The Sociology Program will sponsor a visit from Dr. Julie Kmec, Edward R. Meyer Distinguished Professor in the Liberal Arts from the Department of Sociology at Washington State University (WSU). Dr. Kmec will speak about her research at a campus-wide event titled, "Race Segregation at Work and State Equal Employment Law." As a National Science Foundation (NSF) grant recipient, the author of nearly 30 articles, and an award-winning scholar (see attached curriculum vitae), Dr. Kmec is an expert on state and workplace practices and policies that generate and exacerbate race and gender-based inequalities at work. Dr. Kmec is an engaging speaker and has received mentorship and teaching awards, in part, for her clear and dynamic presentation style. At the intersection of law, employment, and inequality/social justice, this event is likely to draw students and faculty from the Sociology, Political Science, Chicano Studies, and Economics Programs, to name a few. Dr. Kmec will also give one classroom presentation in a Sociology of Gender & Sexuality course (~35 students). For the classroom presentation, Dr. Kmec and I will work together to create an experiential learning activity in which students will learn about one common sociological research method used to study employment discrimination: audit research. Not only will this classroom visit help students understand the importance of rigorous scientific methods for generating sociological knowledge, but it will prepare students for completing their own individual audit research project later in the semester. Finally, Dr. Kmec will host a graduate school information workshop, open to all Sociology students interested in attending graduate school (~20 students). Dr. Kmec will draw on her three years of experience as Director of Graduate Studies for the Department of Sociology at WSU to provide students with tips and tricks for making their graduate applications stand out. These tips include, but are not limited to, writing a compelling statement of purpose, approaching | | |
| | Dr. Kmec's visit will help Sociology students achieve our Program's learning outcomes. For example, Dr. Kmec's graduate school workshop will help Sociology students' preparedness for professional or graduate study beyond the B.A degree (http://sociology.csuci.edu/learningobjectives.htm). Her research talk will provide students with an example of the role and process of scientific inquiry in the creation of social knowledge. Students will be able to explain the procedures of one sociological research method—audit research—in detail and articulate the value of this research method for uncovering subtle forms of labor market discrimination (classroom visit to Sociology of Gender & Sexuality). Students will learn "best practices" for securing letters of recommendations and preparing personal statements (graduate school workshop). Students will develop a "to-do" list and timeline to help them work towards: 1) researching graduate school entrance requirements, 2) researching particular graduate programs, or 3) preparing/revising graduate school admission materials (graduate school workshop).
