Estimated Number of Students Participating	Over the years, this equipment will be used by many students. In addition, this equipment will be used in CI events and activities, so participants will be able to have access to the information presented in Spanish.
Conditions and Considerations	
Brief Activity Description	The Spanish Program is requesting the purchase of a portable simultaneous interpreting system through IRA funds. As the Spanish Program is introducing language interpretation courses in its curriculum, it is a vital to provide students with the necessary training on simultaneous interpretation (which cannot be done without the requested technology). This interpreting system will allow students to practice their interpreting skills

	inside and outside of the classroom.
	In addition, this equipment will also be used for CI community events, where Spanish interpretation services are needed or requested. Thus, students, under the supervision of a faculty member, can practice in real life events, such as honors convocation, the EOP banquet, Discover CI, Noche de Familia, or any other event where monolingual Spanish speakers are present. As a Hispanic Serving Institution, we should be able to provide this kind of services to our community.
