Brief Activity Description

This proposal grew out of my desire to begin a music series here at CSUCI similar to the monthly series I hosted for 8 years as director of Thousand Oaks Library. I chose to bring Perla Batalla to campus because she:

- 1) Is a Grammy-nominated vocalist/writer. Her Grammy nominated record is "Mestiza," which celebrates her Mexican heritage.
- 2) Has toured worldwide as a vocalist for Leonard Cohen.

This IRA grant would:

- 1) Support a concert by Perla Batalla who will present the songs of Leonard Cohen. album.

Leonard Cohen's work has explored religion, politics, isolation, and personal relationships. Cohen has been inducted into both the Canadian MusicHall of Fame and the Canadian Songwriters Hall of Fame as well as the American Rock and Roll Hall of Fame.

- 2) Allow a broadcast video to be made which would serve two purposes. One is to have the event available on video for those who might have missed it. The other is to provide a way for the general public to have a sense of the many activities going on at CSUCI.
