#### **Brief Activity Description**

Pacific Standard Time: LA/LA is a far-reaching look at Latin American and Latino art in dialogue with greater Los Angeles involving various sites and partners throughout Southern California, including CSU Channel Islands (CSUCI). Included in this effort is the exhibit "Found in Translation: Design in California and Mexico 1915-1985" which examines bi-national cultural exchanges that have shifted the function and aesthetics of the everyday over the course of the 20th century, currently showing at the Los Angeles County Museum of Art (LACMA)

As a contributor to this gallery, CSUCI professor Nicholas Centino has secured free entry for a tour group of CSUCI students for Friday February 23rd. Students will be guided through "Found in Translation: Design in California and Mexico 1915-1985" exhibit, but with also be able to tour others currently at display in LACMA. The visit will culminate in an informative talk and presentation on Chicana/o inspired fashions as a form of dialogue between Mexico and California delivered by Professor Centino.

Transportation by LACMA will be by bus. Students will apply via a Wufoo application. Professor Centino will mee with the campus Risk Manager to ensure all field trip policies are followed.

## **Learning Outcomes and Relation of IRA to Course Offerings**

This course directly relates to the learning outcomes of Chicana/o Studies 200 Latina/ Diversity, a course I am offering this Spring. Learning outcomes are as follow:

1. Examine the historical and contemporary relations between Latin America and the United States in connection with the divergent incorporation of Latina/o groups in U.S. society.

In accordance with this outcome, CHS 200 students will examine the exhibit with guiding questions that press them to look for dialogue and exchange between artists and designers in California and Mexico and be able to historically situate those exchanges in a broader context.

2. Gain a better understanding of the diversity and heterogeneity of the Latina/o population in the United States.

The sheer diversity of cultural texts on display (architecture, fashion, murals, furniture) will provide students a broader understanding and increased appreciation for the impact of binational exchange in the borderlands. Guiding questions will allow CHS 200 students to focus their observations which will be debriefed later in class.

## 4. Activity Assessment

## **Description of Assessment Process**

At the conclusion of the trip, students will debrief onsite and share their responses to the guiding observation questions provided at the beginning of the tour. The guiding questions are as follow:

- 1. What is design? How do aesthetics shape our perception of architecture? Fashion? political posters or ads?
- 2. What specific cultural exchanges did you see in the gallery? How were these cultural exchanges facilitated?
- 3. What is the difference between exchange and appropriation?
- 4. Did you recognize any of the cultural texts on display? Has your estimation of those texts changed now that you've seen them in a broader context? Why or why not?

Additionally, developing lasting and sustainable relationships between CSUCI and the Chicana/o Latina/o arts community of Los Angeles can broaden the horizons for CSUCI students interested in fields in design, fashion, architecture, and cultural production.
