## 2. Brief Activity Description

#### **Brief Activity Description**

World War I, then known as the "Great War," was a world-historic event that continues to shape the world into the present day. In recognition of the 100 year anniversary of the cease fire of 1918, the CSU departments of History and Political Science propose a conference on WWI to be held on campus November 8 and 9, 2018.

A call for papers will be issued via the internet and a CSU panel will decide on paper applications for a wide variety of proposals, from the build up to the war, the various reactions from the belligerent powers, how the war affected various sectors of the warring parties, how the war expanded, and how the war finally came to an end.

We propose a two-day conference with morning and afternoon session at a location on campus to be named later. We hope to attract two scholars renowned in for their expertise in the study of WWI, and each will receive compensation for transportation and lodging.

## **Learning Outcomes and Relation of IRA to Course Offerings**

HIST 212 - World Civilizations: Since 1500: WWI is a central topic in World Civ. Since 1500

HIST 271 - The United States Since 1877: the U.S. became a world power as a result of WWI

- HIST 319 European History, 1871-1945: WWI reshaped the map of Europe and transformed the societies and economies of the region.
- HIST 322 Modern Russia: 1855 to Present: WWI saw the abdication of Czar Nicholas II and the transformation of Russia's political, social, and economic order
- HIST 349 History of Business and Economics in North America (Cross-listed as ECON 349, BUS 349): North America benefited economically from WWI, and it's societies and economies were greatly affected by WWI
- HIST 357 History of Capitalism: WWI was part of a broader dynamic of a world capitalist system in crisis, with nations competing over access to markets, raw materials, and labor
- HIST 372 United States Industrialization and Progressivism: WWI gave a great boost to U.S. industrialization which in turn helped stimulate the Progressive movement.
- HIST 373 American Labor History: WWI was used by the government and private sector to undermine the growing labor movement in the U.S. and the world
- POLS 102 Comparative Government: The nations involved in WWI ranged from brutal monarchies to open, democratic governance. This conference provides a perfect format to analyze the various systems of government in operation between 1914 and 1918.
- POLS 103 Introduction to International Politics: WWI was an international conflict involving international political rivalries.
- POLS 150 American Political Institutions: American political institutions underwent a transformation as a result of WWI. Courts were empowered to go after "subversives," while the U.S. government nationalized the rail system.
- POLS 301 Political Theory: From Antonio Gramsci to V.I. Lenin to Winston Churchill, WWI had a huge impact on the development of political theory
- POLS 306 The Politics of Race and Ethnicity: WWI unleashed nationalist movements that impacted on Europe in the 1930s and well into WWII. Our modern sense of nationalism is rooted in WWI, waged allegedly in the name of nationalism and ethnic solidarity
- POLS 313 The United States Congress: Congress declared war, voted funds for the war, justified the US role in the war, and empowered the government and courts to arrest labor and anti-war activists in the name of prosecuting the war.
- POLS 314 The American Presidency: WWI pushed the executive branch further on the road of an "imperial presidency," since the president is also "commander in chief," which, in time of war, concentrates even greater power into the hands of the president.
- POLS 319 Political Behavior and Public Opinion: WWI was not a popular war, and the mobilization of US troops to Russia after the war was so unpopular it was kept largely a secret. How the US government and business community were able to impose an unpopular war on the US public is a key element to WWI.
- POLS 328 United States Foreign Policy: WWI transformed US foreign relations and began the process of transforming the US from an "isolationist" nation to a world power engaged on a global level.
- POLS 329 International Law and Organizations: The Versailles Treaty altered the field of law and global organizations. the League of Nations was created, and while nominally independent, Middle Eastern nations fell under the paternalistic hand of European powers.

### **Description of Assessment Process**

The conference will be taped and reviewed after the conference is over. Students will be interviewed to determine what impact the conference had on them. To inform the student body about the significance of WWI is the goal of the conference, and in interviews following the conference it will be decided how effective the conference was.
