2. Brief Activity Description

Describe the activity and its relationships to the educational objectives of the students' program or major

Brief Activity Description

This 60 minute presentation will address the plight of veterans in California. Ventura County is home to several military bases. Understanding the needs of veterans and possible interventions are necessary to promote their health and well-being.

Ms. Mitchell served in the United States Navy for 17 years as a Surface Warfare Officer serving on board surface ships and at shore commands achieving the rank of Lieutenant Commander. She was hand selected by the Secretary of the Navy and the White House to serve as a White House Military Social Aide where she assisted the President and First Lady from 2007-2012 in hosting more than 500 events. During her last 2 years on active duty she served as the Deputy Director of the Chairman of the Joint Chiefs of Staff Office of Warrior and Family Support. Ms. Mitchell was President and Co-founder of Dixon Center for Veterans and Military Services for 5 years prior to becoming Chief Executive Officer of Veterans Village in San Diego (VVSD) in 2017. She has worked with hundreds of communities, assisted thousands of organizations and has created a nationwide network of support utilizing grassroots solutions to address the challenges of transition and reintegration for our service members, veterans and military families.

As an infant, Kimberly Mitchell was found next to her dead mother's body on a bridge in Vietnam right before it was blown up. The man who found her named her Ngoc Bich or precious pearl in Vietnamese. Soon after she was adopted by an Air Force sergeant and came to the United States.

This all campus event relates to a variety of programs on campus, including Nursing, Health Science, Sociology, Psychology, and Education to name a few. Of particular importance are the veterans attending CSUCI, family members of veterans, or those planning on working with veterans in the future. Currently CSUCI has 98 veterans and 238 dependents of veterans, roughly 5% of the student body, attending the university.


