Brief Activity Description

The ESRM Environmental Film and Speaker Series uses current and classic environmental films and documentaries to address current environmental issues. The class brings such guest speakers as authors, professors, community activists, environmentalists, non- and for-profit business representatives, and government officials to present on specialized subjects including renewable energy, green business, environmental justice, green city planning and sustainable food systems.We seek support to bring six seminar speakers to campus for our interdisciplinary speaker series. Our spring seminar has grown increasingly popular and now routinely draws at least 20-40 students per speaker and 10-20 faculty and community members. While ESRM and Biology are the most common attendees, the audience comes from across campus and local community. We are seeing increasing interest in other disciplines for these seminars (English,Communications, Political Science,History, etc.). If this proposal is successful, 2018-2019 would be the 11th year of the seminar series.

Students enroll through ESRM 496. The Environmental Film Series runs in the Fall semester and the Speaker Series in the Spring. Each semester follows a theme that addresses current environmental concerns of interest to the program and the wider campus community. Films and Speakers will touch on a number of topics and concerns regarding contemporary environmental management challenges and citizen engagement with them, all of which reinforce course-specific as well as general program learning outcomes:

- Understanding the resource management issues of the day

- Articulating the interdisciplinary nature of modern environmental challenges

- Proposing novel solutions to existing resource challenges

While the exact lineup of films and speakers is not finalized for next year, the topics addressed in ESRM 496 Environmental Film and Speaker Series speak directly to sustainability and the need to live more sustainably on our planet. Previous year's themes of the film class include 'Water', 'Human dimension of the Environment and Sustainability', 'The True Cost of Consumption', 'A Solutions Oriented Approach to Environmental Problems' and 'A Sense of Place'. Many of our past speakers have directly addressed CI sustainability issues in previous semesters as they relate to local solutions to address environmental challenges. Often these examples relate to food, the built environment (e.g., lighting options and energy efficiency), and green accounting/certifications (e.g., USGBC LEED certification); this spring speakers will focus on different avenues of civic and career engagement with environmental issues that are available to today's college graduates.
