Learning Outcomes and Relation of IRA to Course Offerings

Among the learning outcomes of this class are being able to identify major phyla of invertebrate animals, mesh these types with their habitats and identify human impacts on invertebrate populations and their habitats.

A trip to Santa Rosa Islands allows us to experience ocean and island habitats. The trip is scheduled around a low tide day, so we are able to practice finding and identifying different invertebrate animals in their natural habitats. Many other lessons in biology, conservation, ecology offer themselves to us as we explore the island.
