#### **Brief Activity Description**

The Daniel Lee Memorial MusicFest is designed with two goals in mind. First, the festival will be an even that honors Daniel's love of music – and his love of sharing community and friendship through music. Second, the event will be a fundraiser for the Daniel Lee Memorial Scholarship fund. To tie the two together, we have considered having the fall musicfest event during international week, and to try to focus at least some portion of the event on international musical themes.

The day and week (for the third year, we are partnering with the International Office and celebrating Dr. Lee and International Week) should have twin emphases: participation and exhibition. The participation emphasis draws from Daniel's love of the community and sharing aspect of music. This emphasis seeks to draw in students (and faculty and staff and community, etc.) to contribute their own interests and talents in some way – even if they are simply hobbyists. The natural venue for this type of participation is an open-mic event. The exhibition emphasis draws from Daniel's love of and interest in all types of music. We will seek to present quality music of a variety of sorts to an audience on campus – ideally, with some of it of an international characteristic. The best venue for this type of exhibition is a focused event in the evening.

#### **Learning Outcomes and Relation of IRA to Course Offerings**

The Daniel Lee Music Fest is not tied to a particulary discipline ou program, but is very much linked to a number of campus wide student learning outcomes as well as to individual class objectives.

The festival, like Daniel's scholarship, is informed by our missioin based centers. Certainly, there is a service learning opportunity for musicians and student volunteers who will assist in making the festival happen. As mentioned, all raised proceeds will be applied to International travel opportunities for our students. Further, many of the acts and musicians will feature international music (Irish, for instance), that will create a multi-cultural experience for attendees. Last, the program of performers will be drawn from across our campus community and will display the talents of many that borrow from disciplines to the benefit of their studies, work, and creative activities.

In regard to specific classes, it is clear to see the relationship between this event and Performing Arts and our International Studies programming, which can include Language, Geography, and Global Studies classes. It should be noted that this opportunity coincides nicely with the Music Department's requirement that students perform live--this festival provides a forum for PAMU students to succeed academically.

#### **Description of Assessment Process**

The Daniel Lee Music Festiaval is or will be annual event at CI and is an important part of our culture and curriculum. The

event will be advertisedthroughout the campus and we hope will live on in collective memory. Certainly, we will report statistics associated with the event, particularly attendance. But the true measure of success will be the participation of our CI students, staff, and faculty.

A video will be created and posted into the Library's Institutional Repository insuring preservation and access to the event. Editing and preparation continues on a video that we took last semester by a CI undergraduate art major.

In addition, we will adverstise money raised for the travel scholarship. This scholarship will be awarded to students traveling as part of a UNIV 392 course. Students receiving money from this scholarship will write a reflection and submit images and or sounds/songs from their travel that will be collected and posted in the Library. Likewise, these reflections and collected aural pieces will be used in subsequent years to both market the event in future years but also as a place where people interested in Daniel can visit. For instance, perhaps we create a Facebook page that will continue to grow both as people who remember Daniel add content as well as students that might never have known him share their experiences travelling due to Daniels shcolarship or performed during the concert.

# Other Sources of Funding The scholarship fund began with a generous donation of \$25K from Daniel's brother and his wife, Andy and Ria Lee, earmarked for supporting scholarships for international engagement among our students – generally those who face some financial challenges to doing so. (That is currently being held in an Advancement account for the Daniel Lee Memorial Scholarship Fund.) The family was kind enough to match that donation shortly thereafter and we will be offering our second \$1,000.00 travel abroad scholarship in AY .18/19.Our goal as stewards of that fund is to find the best way to use it to support students. Several questions have to be answered about how to do so. We've also partnered with the Center for International Affairs whose faculty director, Dr. Andrea Grove, has pledged \$1,000.00 in support of our efforts. 8. Promoting Participation What is your intended audience and how do you intend to market this to your students? The Daniel Lee Committee has met with Housing, ASI, and the Student Programming Board concerning possible partnerships, particularly in regard to student participation. We discussed the possibility of joining the Dolphinpalooza event but opted to keep this one separate, largely due to calendar issues--our event last year was in August, and it makes sense to continue hosting our event in the Fall. At our Fall event, the turnout and pariticipation by musisians (students, faculty, and staff) was huge and extremely encouraging. Estimates suggest that 125 people attended and that suggests that we have every chance of contunuing as a draw.
