2. Brief Activity Description

Brief Activity Description

A theatrical workshop of an adaptation of Lewis Carroll's Alice's Adventures in Wonderland by Elizabeth Rothrock.

The focus of this adaptation is exploration of identity. Throughout Carroll's original story, a bemused Alice often observes that she is unable to recognize herself; that she has changed, that she is no longer certain that she is still herself. Indeed, we know that each time she eats or drinks according to written instructions, she changes radically – she grows to monstrous heights, or shrinks to near helplessness and very nearly drowns in her own tears.

This workshop will serve as a laboratory for development of a play script into an eventual full stage production, possibly for performance in fall 2019. Participants may include CI students, faculty, and staff, as well as local children/youth. We will meet 5-10 times to experiment with the script-in-progress through improvisation, creative movement, dance, music, and puppetry, and present a concluding performance. The goal of this theatrical workshop is the development of a play script for production of the Alice story that is unique, inclusive, and representative of the struggle we all navigate on our journeys to ourselves.

In this new interpretation, a different actor will play Alice in nearly every scene – Alice will therefore appear to change radically! Actors playing Alice will be of any gender, any culture or ethnicity, of any age, and may speak any language as she journeys through chaotic Wonderland. Is she searching for the elusive magical rabbit, entrance to a beautiful garden, a true friend, herself, or a place of belonging? She pursues each and more in the story. We will explore this through navigation of identity.

Learning Outcomes and Relation of IRA to Course Offerings

PATH 101 Introduction to Theater: Outcome: Understand that theater as a live performing art form emerges from, and produces culture. Outcome: Participate in a theatrical production.

(Participants in this workshop of Alice's Adventures in Wonderland will collaborate to create a new performed interpretation of the story as an exploration of identity. Participants will experiment with theatrical forms such as creative movement and puppetry during the development process and then perform the play.)

PA 202 Integrating Dance, Music, Theater: Outcome. Understand application of methods and philosophies of performance integrating dance, music, and theatre. (Participants in the workshop will explore a variety of dances, both historic and original, for inclusion in the production, and; Create and test original melodies for Carroll's songs.)

PATH 280 Acting 1: Outcome: Participate in activities that emphasize voice, movement, improvisation, monologues, and scenes. (As development of the script proceeds through the workshop process, participant actors will work through improvisation, monologues, scene and voice work.)

PATH 281 Play Analysis: Outcome: Understand the application of the analytical tools used by theatre professionals with play

scripts, including dramatic structure and its relationship to performance and production. (Participants will necessarily analyze the development of the play script.)

PATH/EDU 343 Teaching Drama to Children: Outcome: Participate in theater and drama activities. Outcome: Design and implement drama as a learning tool.

(Workshop participants expected to come, in part, from one of Rothrock's three sections of PATH/EDU 343. Students in this course are, for the most part, emergent teachers interested in doing drama work with children and youth. Part of the stated intent of the project in to include child participants. This, among other benefits, provides opportunities for our future educators to work with children on the development of a theatrical production.)

PATH 380 Acting 2: Outcome: The development of character. (Alice's Adventures in Wonderland provides a remarkable diversity of characters for actors, perhaps second only to the works of Dickens.)
