Brief Activity Description

This Academic Year, 2018-2019 will include six separate lecture/demonstrations from award winning composers, producers and engineers. The visiting professionals will share their paths to success and in the music, tv and film business. Our IRA lecture series brings in top level composers, recording engineers and musicians from LA/Hollywood to CI to share their experiences with CI Audio Design and Recording Class. All other members of the CI community will also be welcomed to join my class for these event. Our guest artists will demonstrate compositions and recording techniques, and they will share some of their award winning compositions and recordings.

There will be interactions with the audience in the form of question and answer exchanges. The topics that will be presented will correspond directly with the techniques that we study in PAMU/ART 385.

Feedback collected from past students in this course overwhelmingly shows that these lecture/demonstrations really make our courses "come alive" for the students, and greatly enhance our students' understanding of the concepts being learned in this course. Past students have expressed much gratitude for these live concert/lecture events, and the students remark that these interactions with our professional guests do greatly contribute to the understanding and comprehension of the course's lessons and content.

The professional composers, producers and engineers will do a lecture/demonstration/ Q & A session. The students will witness music literally "come to life" in a live recording session and in the performances by professional musicians. The musicians will also demonstrate techniques and discuss what goes into being a composer, engineer and musician. The students will then be able to ask questions to any and all of the professionals related to recording music, life as a composer/musician, etc. By bringing the outside world into the CI classroom, students are exposed to a unique multicultural event and learn firsthand about working in the entertainment industry, the dedication, work habits, and spontaneous collaboration that happens in the recording studio.

My students are required to write a report about their impressions, observations, and analysis of the music elements that they witness during the lectures/demonstrations.

I require my students to complete a post-event Qualtrics survey about each IRA event.
