### 2. Brief Activity Description

#### **Brief Activity Description**

Santa Rosa Island provides a unique laboratory that illustrates many of the elements in the Principals of Resource Management course including endangered species and wildlife management, protected area management, marine and coastal resource conservation, ecological restoration, and watershed protection and management. One of the goals in the 200 course is to introduce students to the broad array of potential research opportunities in the region through interactions with faculty, staff, and community partners such as the Fish and Wildlife Service, National Park Service and Sate and local park units. During this field experience students would be given the opportunity to experience a range of land management challenges and their solutions on the island. Additionally, students will be exposed to potential capstone undergraduate research opportunities that will provide a "springboard"to future involvement with the research station. Students will be introduced to long term monitoring of the island involving Torrey Pines, Island Fox, and restoration of island vegetation through peer mentors and SRI staff. These long term monitoring efforts provide ideal undergraduate research opportunities and important capstone topics. Students will be introduced and conduct numerous field observations using proven transect protocols during their time on the island which will provide future cornerstones for individual research efforts.

#### **Learning Outcomes and Relation of IRA to Course Offerings**

The following are course learning outcomes for ESRM200 followed by a brief narrative on how this trip relates: -

Demonstrate an understanding of the relationship between conservation initiatives and the local community-Santa Rosa Island (SRI) provides an incomparable learning laboratory for exploring the nexus of community and conservation. Understanding Park Service outreach and education efforts are important for students at this stage of their development. Define environmental problems from the perspective of both environmental science and resource management-SRI provides clear examples of basic biological problems (overgrazing by introduced species), and their management solutions (eradication of deer and elk).

Identify possible causes and propose solutions to environmental problems from the perspective of both environmental science and resource management-One ideal case study on the island involves Island Fox and Golden Eagle predation. This trophic cascade was an outgrowth of species introductions, DDT poisoning of Bald Eagles, and predation on an endangered species by a new predator (Golden Eagles). The decision to eliminate Golden Eagles was extremely contentious and created new NPS policy.

Make use of current technological tools in the collection, organization, analysis, and interpretation of data-There are many examples of these new tools (SUV's, UAV's, GPS, GIS, etc.), being used on the Island and students will be exposed to numerous field methods during their visit.

#### **Description of Assessment Process**

Working in teams students will access historical data regarding Torrey Pine and Island Fox populations prior to their visit, and utilizing new field assessment approaches, they will reassess historical data to determine current management effectiveness. Throughout the semester class discussions will involve various aspects of resource management with a particular focus on habitat conservation. During the trip to SRI students will be prompted to reflect on their experience on SRI as it relates to topics covered throughout the semester. Students will be asked to provide written reflections about their trip and their experiences. These written reflections will be posted on the class website and course blog to provide future discussions involving capstone opportunities.

A visit to Santa Rosa Island provides students with the opportunity to be immersed within the ecosystems they are learning about in class and to view first hand conservation and restoration issues that are ongoing on the island.

Since the Channel Islands are an integral part of our campus culture, it is imperative that students be given the opportunity to see how these protected areas benefit local communities. Since students will be paired with senior capstone researchers on the island, their contributions will be acknowledged by senior students and reflected at the ESRM capstone poster presentations.

This project focuses primarily on environmental education, one of the five primary areas of sustainability identified by the CI Sustainability Task Force. Exploring an area now protected as a National Park and in recovery from extensive human influence will educate students in sustainable practices and the use of coastal and marine resources.
