2. Brief Activity Description

Brief Activity Description

This first-ever CI student songwriting competition and Performing Arts (PA) student recording was a landmark event for CI. Wsecured four-time GRAMMY award winner and legendary Beatles engineer, Geoff Emerick to be involved in the competition and recording project from its inception to its finish. The process of this project is: In October 2018 a call will go out to students' campus-wide to submit an original song for the competition. I and other PA colleagues will narrow down the submissions to 10-15 songs. In November, Geoff Emerick, Emmy award nominated Television composer of two and a Half Men and Mike and Molly, Grant Geissman, CI President Dr. Ericka Beck and myself, will judge the competition and select four songs. These lucky winners will then have their songs arranged by myself for the PAMU 310 ensemble (which includes a full horn section and backup vocalists), then rehearse throughout the spring semester and record at the end of the semester. The recording will take place at LAFX, a professional recording studio in Los Angeles which includes some of the best vintage equipment in LA, including a \$150, 000 analog API soundboard for recording. The songs will be recorded and mixed over several days, and then mastered at Golden Mastering in Ventura. Artwork will be done by a current CI Art student or recent alumni. The recorded music and artwork will then be submitted to the disc maker website and later released on over 25 musical distribution websites. This project is a full academic year of planning. Mr. Emerick has agreed to help me oversee the entire recording project which will feature several other student-based ensembles and students who are studying privately. We plan to use recordings of the PAMU 490 Steel Drum ensemble, the PAMU 204 African Drumming, the PAMU 310 Contemporary Music Ensemble, and the PAMU 307 University Chorus for the completed CSUCI Performing Arts Student Showcase. Mr. Emerick and myself will be co-producing the project and are in charge in charge of having all these various groups recorded, mixed and mastered for the project. We were incredibly lucky to have our CI students get a chance to work with a legend in the music business in Mr. Geoff Emerick and record a professional recording studio.

What is your intended audience and how do you intend to market this to your students?
This year-long event will be advertised via posters and fliers that have been made for us by ART 499 Capstone students that we will put all over campus. It will appear on the TV screens in Library, SUB and elsewhere. We will also send a campus-wide email to all students, advertise it on the CI and PA websites as well as CI and PA facebook pages and have students share it on facebook and Instagram. Last year well over 100 CI students participated.
If this is an event that is off campus, how do you plan to bring back the benefit of this event to campus?
Some of the activities involved in this project will be on campus. For example, the demos that we will receive for the competition will be recorded in our CI Napa studio, we will also have the competition itself that will be in November when the participants who made it through the first level will get to perform their songs for the prestigious judges. For the recording, which will take place in a professional Los Angeles studio, we plan on getting several hundred albums made which can be placed in the bookstore in our Library and elsewhere. The lucky winners will then have their songs released on over 25 musical distribution websites. Last year, we also brought it back to campus by performing the Student Songwriting winners songs live with the PAMU 310 Contemporary Music Ensemble at both of night of Arts Under The Stars. These performances were viewed by hundreds of attendees. We also just recently performed (upon request by President Erika Beck) the songwriting winning songs at the Faculty convocation luncheon for over one hundred faculty, staff, and student workers at the beginning of the fall 2018 semester.
