- 2. Brief Activity Description

Describe the activity and its relationships to the educational objectives of the students' program or major

Brief Activity Description

The course consists of three weeks based in Paris, France, at the Paris American Academy. Students will be visiting over 12 museums and cultural sites which include: the Louvre Museum, Musée D'Orsay, the Eiffel Tower, the Georges Pompidou Museum of Modern Art, the L'Orangerie Museum, the Picasso Museum, the Marmottan Museum, the Grand Palais Museum, the Cluny Museum, Deyrolle museum, as well as excursions to Monet's Giverny and the Versailles Chateau, among local gardens and other cultural places of interest.

Students will be housed in local well-appointed Paris apartments with separate bedrooms and full kitchens and baths, that are in close proximity to the Paris American Academy in the Latin Quarter of Paris in the 5th arrondissement. There are typically 2-4 students per apartment. They are managed and maintained by the Paris American Academy.

This course is open to any current CI student. It is not limited to art majors, any student from any major may apply.

The course touches on all of the University Mission pillars as well as other high-impact learning practices:

INTERNATIONAL EXPERIENCE: The UNIV 392, Art in Paris will provide a unique 3-week study abroad experience incorporating internationalized curriculum.

STUDENT CREATIVE RESEARCH & ARTISTIC CREATION: 40% of students' grades will be based on both student research through the creation of varied types of artwork inspired by museum visits, artistic introspection, creative investigations and art-making based on their 3-week experience in Paris. While living and experience the wonders of Paris, student will analyze the new world around them and thereby develop unique thoughtful artwork using personal artistic tools and techniques.

MULTICULTURAL: The program will emphasize embracing diversity and multiculturalism along while participating in artistic and creative endeavors. Students will be actively engaging with a global community in France, thereby embracing a world and culture different than their own. The trip will allow them to view historical and culturally significant artworks while collaborating on the creation of their own personal artworks.

INTEGRATIVE/INTERDISCIPLINARY STUDY: Curricula provided in this program will promote integrative and interdisciplinary understanding. This includes the study of Art (Studio Art), Art History as well as History (History of France and Europe) as it relates to artwork studied in museums and cultural locations.

COMMUNITY ENGAGEMENT: 20% of students' grades will be based on the completion of a final art exhibition which will be the culmination of their international experience at the end of the course in Paris. It will be a group exhibition, curated by the students and presented to the Paris public. Upon returning home the students will organize an exhibition in the Fall of 2019 to exhibit the work they created on the trip and discuss their work with the CI community and broader community at a gallery exhibition on campus.

Description of Assessment Process

Students are assessed on their participation in all museum visits and cultural excursions, the projects they create while in residence in Paris, as well as their overall artistic development related to the artwork they produce. Projects consist of assignments in drawing, painting and writing (a written essay). Students will be involved in assessment of their artworks in the form of one-on-one instruction and critique as well as art critiques with their peers. Art projects created in Paris will be exhibited in Paris at the Gallery Val du Grace at the Paris American Academy during the last week of the trip. The Paris public and PAA staff and faculty will be invited to attend. The same projects will be exhibited at the Palm Temporary Gallery, Napa Hall on the Cl campus during the semester following the program's end.
