# - 2. Brief Activity Description

## **Brief Activity Description**

I would like to create a unique opportunity for students to learn about how to be a music creator in television, film, ads, and gaming, and then to compete for a chance to pitch their own music directly to music sync agents or music supervisors. I would like to bring Tess Taylor, the president of the National Association of Recording Industry Professionals (www.narip.com), to give a presentation on music sync licensing (she is currently writing a book about her decades of experience in the business), and then have her return to judge a competition of student-produced music tracks. Tess has given this presentation multiple times at CSU Northridge and other schools, but I would like to go further and give students an immersive experience that gives them real-life experience by putting them in front of the gate-keepers in the music industry.

The winners will earn the chance to pitch their music in a NARIP pitch session in Los Angeles with the possibility of signing with a music licensing label or pitch directly to music supervisors. In any scenario, the winners will begin to develop invaluable relationships in the music industry with a real chance to earn income and future royalties from their music. As this would be a CSUCI Performing Arts Department-backed project, the department would also be eligible for royalties/payment split should any future placements in tv/film/ads/gaming occur. Part of the budget proposal includes funds to help students produce their tracks in our Mike Curb studio.

I will collaborate with my music colleagues to have this event attended by as many music classes as possible. The competition itself will be similar to a NARIP pitch session. Students will pitch 3 tracks and will be coached by Tess about how to refine their pitch. The judges will include music faculty and President Beck if she is available to participate.

In an effort to grown our music theory program, my courses specifically, I would like to suggest making the competition open to students who have taken PAMU 161 Music Fundamentals or would be currently enrolled in Spring 2020.

For students entering the competition, students will gain experience collaborating with others to produce music. For competition winners, students will get the unique opportunity to experience the music business first hand.
