- 2. Brief Activity Description

Describe the activity and its relationships to the educational objectives of the students' program or major

Brief Activity Description

This trip to Santa Cruz Island will focus on the effects of human societies on natural ecosystems for students taking the Fall 2019 Ecology and the Environment course (Biol 433). The Channel Islands in general provide a snapshot of what the mainland likely looked like approximately a century ago. This field trip to see relatively intact habitat will help students put local conservation issues associated with commercial, residential, and industrial development on the mainland into perspective. In addition to conservation, this course also covers the theory of island biogeography and island endemics (both at the species and subspecies levels). Physically going and visiting the islands will be integral for students to gain first-hand experience and apply concepts previously discussed in the classroom. Students will encounter the variety of wildlife from various habitats, from pelagic while on the boat to intertidal/beach upon arrival at the island to grassland during a day hike. This will expose students to multiple taxa and communities within a single day, which is difficult to achieve on the mainland. Prior to and after the Santa Cruz Island trip, students will have taken local field trips on the mainland, and this island trip will provide a important comparison of island and mainland ecosystems.

Learning Outcomes and Relation of IRA to Course Offerings

This activity will support the learning outcomes of Ecology and the Environment (Biol 433) including the following:

• Ecological characteristics of natural ecosystems and basic effects of human society upon those systems.

• Plant and animal distribution patterns in relation to past and present physical and biotic factors.

• Issues of resource management, population, food production, global environmental problems will also be emphasized to explore future directions.

• Field trips to local ecosystems will be taken.

Description of Assessment Process

1. Students will keep a journal (or field notebook) to document their trip to Santa Cruz Island. Journaling assignments are introduced the second week of lab at the beginning of the semester and continue through the entire semester. Students' journal entries are graded multiple times throughout the semester. They will be given time while on the island to write a journal entry, and this island journaling activity will be highlighted. This has an open-ended structure that includes a narrative of their observations as well as a species list and summary of abiotic factors.

2. For the lecture portion of the course, students also do a series of short writing assignments throughout the semester. After returning from the trip, a prompt for a writing assignment will be to compare and contrast the similarities and differences of an island location with a mainland location (e.g. Prisoner's harbor with Ventura harbor) including an assessment of both biotic and abiotic factors.

What is your intended audience and how do you intend to market this to your students?

Ecology and the Environment (Biol 433) is a General Education course for Upper Division Scientific Inquiry & Quantitative Reasoning and also relates to the Interdisciplinary Approaches Mission Pillar. It is open to any student who has completed a single semester of Introductory Biology (Biol 200). As a result, the course is taken by students from outside of the Biology major and even from other disciplines outside of STEM. It is typically a diverse mix of sophomores, juniors, and seniors, with most having never visited any of the Channel Islands before.

If this is an event that is off campus, how do you plan to bring back the benefit of this event to campus?

Ecology students going out to Santa Cruz Island will share their experience with other students and faculty at the university. This, along with social media posts to the biology webpage, will make others aware that there are opportunities to visit the Channel Islands other than spending a weekend at the SRIRS.

Santa Cruz Island is closer than Santa Rosa Island, and as a result it requires less time and money for a visit. The model of visiting more accessible islands can be used by other faculty to take classes out for shorter trips since availability to stay overnight at the SRIRS is limited.
