Brief Activity Description

The field trip is part of a course POLS 312 and a requirement for the class. The story of the Santa Rosa Island is a story of interest groups. From conservationists, to farmers, ranchers, environmentalists, the National Park Service and others, the history of the as told through its players is a natural backdrop for a course on Interest Groups.

The field trip to the island deepens the course content. If the study trip is approved, the course will be anchored on Santa Rosa Islands as a case study of interest group theories. All course content will be using the islands to illustrated theories of collective action, including typology of interest groups, mobilization, logic behind collective action, competing interests, counter-mobilization, framing, strategies including lobbying, and social movements.

POLS 312: Interest Groups and Collective Action, Fall, 2019-Team Taught by Dr. Tiina Itkonen and Tim Allison, J.D. Throughout the semester, specific examples, projects and speakers will supplement the weekend island trip experience.
