Brief Activity Description

We seek to bring in speaker to deliver four separate presentations (two/semester) about Native American approaches to conservation and restoring ecological systems. This semester (Fall 21') one presentation will be specifically directed to our restoration students (ESRM 352) and the other to our wider management-interested students (ESRM 462). Next semester (Spring 22') one presentation will be directed to our Conservation Biology students (ESRM/BIO 313) and another to our students interested in field methods and biological surveying (ESRM 351).

We will record all four live presentations and then make these available to future student/courses as well as our three ESRM 100 courses this semester, and all sections next semester, in an on-demand format (hosted on YouTube).

Bio: Indigenous cultural and plant expert, Nicholas Hummingbird, descends from Cahuilla and Apache nations and was the founder and previous manager of Hahamongna Nursery, a native plant nursery in Pasadena. He has worked on the Channel Islands doing large-scale habitat restoration with the National Park Service and consults with landscape designers and architects on plant choice and placement. Nicholas blends commitment to his Native heritage with a desire to share knowledge as a spokesperson for the many benefits of native plants.
