Brief Activity Description

Title: University Chorus Winter Virtual Performance – Celebrating **Black and Brown Composers in Latin America**

The University Chorus (Chorus) will join the effort and determination set out by the Chancellor's Office and the campus community to promote ethnic studies that bring awareness and acknowledge diversities among us and in our field of studies. The Chorus' Fall 2021 winter virtual concert program: **Black and Brown Composers in Latin America** will highlight the intersection of choral singing, music history, colonialism, and the current discussion on race that has been long overdue. The learning objective for such a project is to broaden students' knowledge and elevate their learning experience through studying, rehearsing, and performing a set of choral repertoire that are composed by Black and Brown composers in Latin America. The learning outcome will include a final virtual performance of the program. During the course of the fall semester, the instructor will invite 2-3 Black and Brown composers and/or scholars to join students in roundtable discussions. This will provide students opportunities to contribute their knowledge and questions to this topic.

The project will not only satisfy the learning objectives of studying diverse genres of music, music fundamentals and vocal techniques but will also elevate students' learning experience by emerging history, culture, race, current events, and music to further explore the complexity of human history, social behavior, and expression. It will offer students an intercultural perspective and deepen their understandings and abilities in these fields. The University Chorus will work with the accompanist, and a professional recording team (Arts Laureate) to produce professional quality virtual performance production. The class will then disseminate the virtual performance production via livestream platforms such as YouTube or Vimeo to an estimate of 400 households (Chorus record from the previous virtual performance broadcast). Among the audience will be students, faculty and staff members of CI as well as musicians, composers, and music patrons from all over the world! There will be segments of interviews and narrations about the musical selections and featured composers in the virtual production to guide the audience through the performances. The narrations and interviews will be a collaborative project between the students, the guest speakers, and the instructor.

There are three parts to this IRA Funds request:

- 1. Fund request for the three guest speakers for the roundtable interview and discussion with students at \$500 per speaker = \$1,500.00
- 2. Fund request to hire the rehearsal and performance accompanist. In preparation for the virtual performance, the need of a rehearsal accompanist for the weekly Monday night synchronized virtual rehearsal is crucial. The accompanist rehearses and assists the instructor/conductor during the months of July and August to practice, record and produce rehearsal tutorials to aid the rehearsal process during pandemic. The accompanist also assists the instructor during weekly rehearsals helping students to learn their music efficiently, running additional sectional rehearsals for different voice parts, and making additional rehearsal tutorials per students' requests. The typical fee for hiring an accompanist for the duration of the service such as this project would be about \$3,960 (estimated 66 hours at \$60 per hour rate). Ms. Linda Fern Fay is an outstanding musician who is versatile in various musical genres; she has proven herself extremely helpful to students in and outside of classroom. Our students enjoy collaborating with her very much.
- 3. Fund request to hire <u>Arts Laureate</u> for professional consultation (August December) and to produce final guide videos and virtual performance production: \$6,000.00. Arts Laureate is an elite recording team offering second-to-none audio recordings, HD video, digital production, and virtual ensemble recordings to performance organizations such as the LA Opera, "The President's Own" U.S. Marine Band, Choral Arts Society of Washington, Kansas City Symphony, Virginia Symphony, National Children's Chorus, and hundreds of other organizations and ensembles.

(1) PROVIDE A DESCRIPTION OF THE ACTIVITY

This IRA fund was to support the University Chorus (the Chorus) with its winter choral performance on Celebrating Women Composers. This activity was successfully moved to a virtual performance production due to global pandemic. As mentioned in the original proposal, the intention was to create an integrated concert program to raise awareness of women composers and the significant roles they play in the history of music. It was also intended to promote the very beautiful (but perhaps unknown) works of selected women composers by studying and performing a set of choral concert program featuring women composers throughout the history of music. I am happy to report that with the support of the IRA fund, the Chorus was able to accomplish our goals. The Chorus presented a professionally made virtual choir performance production in December. The virtual production included several choral performance videos, segments of interviews with two contemporary women composers with students, and a narration that included biography of the composers, and the background information of the pieces performed. The virtual performance production was disseminated through Vimeo Video On Demand in December, 2020 to approximately 400 households around the world. The feedback from the audience was overwhelmingly positive. Many virtual performance viewers and student participants expressed the appreciation of such innovative and comprehensive virtual program. The virtual choir program held the community together and helped students to stay engaged with their learning during an unprecedented pandemic.

(2) HOW DID THE ACTIVITY RELATE TO A COURSE(S) AND/OR LEARNING OBJECTIVES?

The weekly virtual choir rehearsals with the instructor, choral assistants, and the accompanist provided knowledge, comprehension, and application of beginning, intermediate, and advanced skills in choral singing. In addition, through virtual rehearsals and performances, students learned choral repertoire, participated in discussions with contemporary women composers, and developed musicianship and performance skills in an innovative ways. Moreover, through this interdisciplinary and integrated collaboration, students deepened their understanding of the relationship between history, humanity, and music that go beyond classroom doors. By studying and performing a musical program that was especially designed for them, our students were able to explore the complexity of human history and expression through performing arts. In addition, this experience gave the students the desired CI GE Outcomes of: 6.1 Convey how issues relevant to social, cultural, political, contemporary/historical, economic, educational, or psychological realities interact with each other. 6.2 Discuss how social sciences conceive and study human 6.3 Use social science methods to explain or predict individual and collective human



University behavior. 7.1 Integrate content, ideas, and approaches from various cultural perspectives. 7.2 Integrate content, ideas, and approaches from various disciplinary perspectives.

(3) WHAT DO YOU SEE AS THE STRENGTHS OF THE ACTIVITY?

One of the many strengths of this activity is to be able to enrich students' learning experiences by providing them an outstanding accompanist during weekly rehearsals and beyond. Ms. Linda Fern Fay went beyond her duty to meet with students outside of rehearsal and made practice tutorials to help our students learn and study their music more efficiently. The process of producing the virtual performance in December demonstrated to our students the necessity and capability to adapt, innovate, and engage with our creativity during very challenging times. This is exactly the type of exceptional learning experience we hope to provide for our students. We want our students to not only gain knowledge in classroom settings but also apply them in the real world. Moreover, disseminating performance virtually to a broader audience and connecting with art and music patrons around the world are significant to our students' overall educational experience. Through such activity, our students also gained opportunity of networking with professionals and patrons around the world!

(4) WHAT WOULD YOU SAY ARE/WERE THE ACTIVITY'S WEAKNESSES?

My students, accompanist, and I have worked hard to promote the virtual choir performance experience among ourselves and to our community. That being said, virtual environment can never substitute live performance opportunity and in-person learning experience in such a course. We all did the best according to our ability, and will continue to seek improvement for future virtual learning and performing platform. My sincere hope is that we will be able to return to face-to-face instruction someday soon, and fill the concert halls with appreciative audience and enthusiastic performers soon!

(5) HOW WOULD YOU IMPROVE THIS ACTIVITY FOR NEXT TIME?

I will continue to maximize the extraordinary experience to our students in the virtual reality by doing the following:

- include the conductor's direction in the guide tracks sooner than last semester
- create several brief tutorial videos to demonstrate "how to", and reduce students' anxiety of self-recording.
