CommonLook Remediation Request

Brief Project Description

The Alternative Media program directly supports the CSUCI mission statement by providing learning tools to supports students within and across disciplines through accessible formats to facilitate learning. The Alternative Media program is looking to support students by providing accessible formats, such as accessible PDF files. Creation of accessible PDFs is a lengthy and complex process that requires many steps. This process includes, but is not limited to, scanning, OCRing text, zoning text, verifying and spell checking, creating tags, and re-ordering tags. This process can vary in length and time depending on the difficulty of the file, such as very complex math, science, and poor scans. For an example of a high-level document, please refer to additional statements on the MSFT CommonLook Summary Report Form. For the files that require high-level processing, the Alternative Media program does not have the additional staffing and/or technology tools necessary for conversion.

We are requesting funding of \$5,000 for outsourcing of production of high-level PDF instructional materials. We would outsource these high-level documents to CommonLook, a PDF remediation company with compliance in ADA and Section 508. CommonLook will remediate files to achieve accessibility and usability.

By funding this proposal, it will not only help enhance the educational experiences for students but also enhance students' overall university experience. CommonLook is an innovative program that can improve student comprehension. One of the goals of this project is the promote graduation and retention rates through quality and accessible PDFs.

While these accessible formats will accommodate students with disabilities, they will also benefit all students in the courses. Accessible PDFs benefit all students by having alternate text for pictures, headings, TOC for large documents, searchable text, and can be used with screen readers or text-to-speech programs such as VoiceOver. In order to ensure PDF accessibility, CommonLook will:

- Scan, identify, and fix accessibility issues in document holdings
- Review and correct the logical structure of the file
- Check and correct tables, including tagging/redesigning complex tables
- Review, and create alternative text if necessary
- Fix Content Order view to enhance use on mobile devices
- Review, verify and fix script functionality
- Review form elements and address accessibility issues
- Test each document with one or more tags-aware assistive technologies
- Ensure the document passes Adobe's Acrobat Accessibility Checker
- Provide a Section 508, or a WCAG 2.0 AA conformance certificate for each document
