These hotspots and data plans are critical to student success as they provide access to internet bandwidth required for student participation in online classes, take advantage of tutoring and library research support, and to access learning materials placed in Canvas course sections by their instructors. The internet access also gives them the ability to conduct research using digital library e-books and databases and are essential for e-mail-based communication with classmates, instructors, and university services.

Driven by increasing demand, the university ultimately purchased 210 hotspots and paid for 12-month data plans from different funding sources in order to make sure students had uninterrupted access to instruction. Each hotspot has been quickly put into circulation for semester checkout to a student in need and each tells the story of a student who could otherwise not complete his or her educational goals, as is evidenced in some early feedback:

"This mobile hotspot was incredibly helpful and made my online class experience possible."

"Unfortunately, I am decently far from any of places with Wi-Fi . I can't afford a car and there's aren't completed sidewalks to and from my house to these places..."
