## **Business Process Overview**

Use the Test Results page to manually enter test scores and related test information for a prospect. Various test information can also be loaded into this page through an external test score data load. Test results are stored under a prospect and therefore can be used when evaluating an application that the prospect will be submitting later in the future.

## **Steps for Processing Data**

- 1. Select the test you are recording.
- 2. Select the Checklist Item Update check box to indicate that the checklist related to this row of data is updated when you run the Checklist Item Update Automated process. When you save the page, the system selects this check box automatically.
- 3. Enter the date this date this test was taken. The value you enter here populates the corresponding field in the bottom region of the page.
- 4. Select how this test information was reported. For example, the data could have been selfreported or received from a testing agency. The value you enter here populates the corresponding field in the bottom region of the page.
- 5. Select the applicant's academic level at the time this test was taken. This level can be different from the applicant's current level. The value you enter here defaults to the corresponding field in the bottom region of the page.

- 6. Select the first test component. Values for this field are determined by the test ID that you selected. Insert rows at the Test Component section if you have several components for a particular test, as shown in the example. In the above example, ACT has four different test components and a composite score.
- 7. Enter the score, percentile, or both for this test component.
- 8. The system automatically populates the test date, data source and academic level fields from the value you entered in the **Defaults for Components** group box. Any of these values can be changed.
- 9. The default for the loaded date is your system date. Edit this field if necessary. If this information is electronically loaded, this field is automatically filled in with your system date the day the data is loaded.
- 10. The index is related to the LSAT test. The LSAT 3-Year Test Index appears if this information has been loaded.
- 11. **Insert additional rows at the Test ID section** if you are tracking more than one test type. For example, you may have SAT scores and ACT scores to record for the prospect.
- 12. SAVE when you have completed entering all the test scores.

Default Acad Level	The education academic level of the prospect when the test was taken. This information will default into the component academic level field. Academic level values are delivered with your system as translate values.	Click on drop down arrow to see all valid values.
Component	Parts or sections of a test being tracked for an individual. The component is tied or linked to the Test ID.	Click on the "Magnifying or Look-up button" for valid values.
Score	The test score for the test component. The score is usually a numeric value.
