Current residents extending their stay past May 20, may pick up keys once their new apartment is cleaned as early as 3PM on Thursday, May 26, and must complete their move no later than 3PM, Friday, May 27.

New residents may move-in between the hours of 9 AM—4PM on Friday, May 27. Check-in will be held in Housing & Residential Education's (HRE) main office. Located in Santa Cruz Village, building E, room E150.

## Answers to Common Questions

**Will I have a roommate?** Yes. Based on the apartment type, (studio, one bedroom, or two bedroom) will determine how many roommates will be residing with you.

**What's provided?** Your apartment is fully furnished with all major kitchen appliances. Below is a list of items we provide in the apartments, as well as suggested items we recommend you bring to help support a conducive living experience.

**Bedroom** includes: extra long bed, mattress, drawers, file cabinet, desk, book shelf, & desk chair. **Bring:** extra-long twin size sheets, blanket, bedspread, pillow, study lamp, iron, alarm clock.

**Bathroom** includes: toilet, shower, shower curtain, mirror, cabinet, sink, towel rack & plunger. **Bring:** toiletries, toilet paper, towels, trash basket, & non-corrosive cleaning supplies.

**Kitchen** includes: refrigerator (do not bring a mini-fridge), freezer, microwave, dishwasher, stove, oven, pantry, waste basket, recycle basket, washing machine & dryer. **Bring:** dishwashing & dishwasher soap, kitchen towels, laundry detergent, food, dishes, utensils.

**Living room** includes: coffee or end table, love seat or lounge chairs. **Bring:** TV (Optional).

Please read your Resident Handbook thoroughly as all residents are required to know and abide by all community living standards.

**Alcohol & Tobacco**, alcohol is NOT permitted in our apartments, except where residents are 21 years of age or older. Alcohol may not be visible or be consumed unless you are 21 years of age or older. All CSU campuses are smoke & tobacco free. The following will NOT be allowed anywhere on campus: cigarettes, pipes, hookahs, cigars, e-cigarettes.

**Health, Safety & Occupancy Checks**, our staff performs monthly safety & security checks to ensure fire & safety regulations are being adhered to, rooms are clean, in good order & occupancy is accurate. Residents are expected to return the room in excellent condition at the end of their occupancy. For fire safety, candles, even decorative ones, are not allowed.

**Vendor & Unit Refresh**, our staff will be completing repairs and refreshing units throughout the summer period. In addition, vendors will be visiting units to complete preventative maintenance. In both instances, notification will be extended prior to work being completed in your space.

**Parking**, obtain a summer parking permit to park in Town Center next to buildings C and D by visiting <https://mycampuspermit.com/csuci.html>. Residents should only park in parking stalls labeled with "SH-UG" placards. **Disaster Preparedness**, the University has a comprehensive disaster preparedness plan for emergencies such as earthquakes & fires, <https://www.csuci.edu/clery/california-campus-safety-plan.htm>. To be prepared, all residents are encouraged to bring an extra blanket, a flashlight, a first-aid kit, & enough imperishable food & water for three days. In addition, we recommend that all residents adhere to maps located in the hallways that navigate evacuation exit routes in the event of an emergency. If you have a mobility concern, please note this information in your housing application under the Health Information section to allow HRE staff be of support in the case of an emergency situation..

**Student Health Services**, for routine personal care, students should be prepared to administer their own first-aid & should have bandages, aspirin & any additional medications they may need on a regular basis. **Meningitis**. Meningococcal immunizations are strongly encouraged for all students living on campus. ## COVID-19 Protocols

For all residents joining student housing for the summer period, whether transitioning from the academic year or a new resident, please ensure that the following is completed prior to your arrival for check-in,

### New Residents:

- Completion of the campus' required COVID-19 Training by 5/26/22 or prior to your arrival on campus, whichever is first.
- A negative result within a 48-hour period prior to your anticipated arrival to campus.

### All residents:

- All residents and supporters must verify they are clear of all COVID-19 symptoms via the [CDC Symptom Checker](#) prior to arrival on campus.
- Bring Identification! If you have your Dolphin ID, please provide it during check-in. New students, if you have not received your Dolphin ID Card, please bring another form of photo ID (e.g. state identification card or driver's license).

### ON-CAMPUS COVID-19 TESTING

Beginning the week of May 23, CSUCI will have new testing hours for the summer.

Anyone in need of urgent testing access because of an exposure to COVID-19 or possible symptoms of COVID-19 can call the Environmental Health & Safety department at 805-437-3550 during regular business hours to arrange testing. If you are symptomatic, please do not come to campus.

Anyone testing on campus must register with Primary Health to receive their results via text message and email. If you accessed testing on campus during Spring Semester 2022, you already have an account with Primary Health and do not need to re-register.
