

Important Housing & Residential Education (HRE), Financial Aid, and Academic Deadlines for Returning Residents to Student Housing:	
April 1	Student Housing Application opens and can be accessed via your myCI account.
May 6	Priority application deadline for Returning Residents to submit specific accommodation request due to
	medical related needs through Disability Accommodations & Support Services (DASS).
May 20	Priority application deadline to complete housing application to be in lottery for premium space assignment.
	Last day to finalize Roommate groups in the Housing Application for all priority applications received by May 20.
May 31 - June 3	Distribute lottery results and room selection instructions (first four WAVES for those drawn in the lottery).
June 6	WAVE 1 – roommate groups of 4.
June 7	WAVE 2 – roommate groups of 3.
June 8	WAVE 3 – roommate groups of 2.
June 9	WAVE 4 – individual room assignments.
June 10	Remaining students who met May 9 deadline who were drawn lower in the lottery for room selection may
	enter room selection portal.
June 13	Last date for returning residents to complete room selection changes.
	Last date for returning residents to modify profile question responses.
	Last day to cancel housing license without cancellation penalty.
	Financial aid verification documents due to the Financial Aid & Scholarships office. Students who submit documents after this date may not have their financial aid funded to their student account on time to meet the August 16 payment due date.
July 1	NOTE: Document submissions must be accurate, complete, and legible in order to satisfy the filing deadline. Students are advised to submit documents as early as possible so that if there are errors or documents are illegible there will be time to resubmit before the deadline.

	Last day to modify meal plan preferences via the housing application.
	Deadline for Returning CI students to be enrolled in 9 or more units.
July 2	Last day to cancel housing license and incur only a \$100 cancellation penalty.
,	Last day to cancel housing license for any reason with a \$200 cancellation penalty.
July 20	After July 20, the University may approve or deny any request, and approved requests will incur the \$200 cancellation penalty, plus daily rental fees for every day after July 20 that the request is submitted.
August 5	Roommate assignments posted to housing application for students who met priority application deadline of May 20.
August 11-12	Financial Aid disbursement. Balances due after financial aid disbursement are due by August 16. Students whose financial aid does not fund on this day should expect to pay outstanding balance due with personal resources until financial aid is settled and funded.
August 16	All University Fees are due: tuition, student fees, room, and board. Students wishing to pay fees in installments are required to sign up for the Housing Installment Payment Plan (HIPP) online in myCI on or before 5 p.m. August 16. August 19	Move In!  Move-in appointment times will be posted in the housing application under the Time Slots step. Students should plan to check-in no earlier than time posted. 	<b>NOTE</b> : Student accounts must be current with required payments made by this date in order to move in, even if they are expecting financial aid that has not yet funded. Students who owe a balance on move-in day will not be able to check in until the balance is paid.
